A1. Basis Of Preparation

Quarterly Performance Review

Revenue of the Group for the second financial quarter ended 30 November 2014 of RM14.15 million was 69.94% lower than the preceding corresponding financial quarter of RM47.08 million mainly due to lower sales from the trading segment.

In tandem with the decrease in sales volume, cost of sales of the Group for the current quarter have also decreased by 71.21% to RM12.79 million from RM44.42 million in the preceding corresponding quarter.

Consequently, the Group reported a profit before taxation for the current quarter of RM84 thousand as compared to a profit before taxation of RM1.66 million in the preceding corresponding quarter.

Financial Year Performance Review

Manufacturing segment

For the six months ended 30 November 2014, revenue increased by 54.78% from RM6.90 million to RM10.68 million mainly due to rental income which has been converted to toll manufacturing during the current period. However, segment profit decreased from RM0.12 million to RM22 thousand due to higher manufacturing costs.

Trading segment

For the six months ended 30 November 2014, revenue decreased by 94.77% from RM37.64 million to RM1.97 million while segment profit decreased from RM0.86 million to loss of RM0.22 million mainly due to no fuel oil export during the current period.

Integrated hotel operation and property investment segment

For the six months ended 30 November 2014, revenue decreased by 40.94% from RM2.54 million to RM1.50 million while segment profit decreased from RM0.47 million to RM83 thousand due to rental income has been converted to toll manufacturing.

Other than the above, the performance of the integrated hotel operation and property investment segment remain quite consistent with that of the preceding year corresponding period in 2014.

B2. Variation Of Current Quarter Results Compared With The Preceding Quarter

Revenue for the current quarter was RM14.15 million compared to RM12.03 million recorded in the immediate preceding quarter.

The Group's profit before taxation for the current quarter was RM84 thousand compared to the profit before taxation of RM0.19 million for the preceding quarter.

B3. Current Year Prospects

Current economic challenges and the volatility of commodity prices and currency exchange rates are expected to continue to present challenging business conditions for the Group. However, the Group will keep pursuing its initiatives to further optimize its operations and mitigate as much as possible the impact of higher input costs.

The Board of Directors believes that the performance of the Group for the remaining financial year 2014/2015 will remain competitive in view of the challenging business conditions.
