B. EXPLANATORY NOTES PURSUANT TO THE BURSA MALAYSIA SECURITIES BERHAD LISTING REQUIRMENTS

1. Review of performance

During the financial quarter under review, the Group recorded a lower turnover as compared to the corresponding quarter in the preceding year. Export sales had dropped by 56.5% to RM30.5million as compared to RM70.2million for period ended 30th June 2009.

The decrease is mainly due to management's prudent stance in temporarily downsizing its capacities pending the completion of the proposed debt restructuring and had been stringent in taking orders in view of the market volatility.

Notwithstanding the dip in the turnover, the gross profit had improved from 9.6% in the corresponding quarter in the preceding year to 14.5% for the current quarter under review.

The Group managed to record a marginal pre-tax profit for the current quarter ended 30 June 2010 of RM0.3mil as to a loss of RM9.7mil in the preceding year corresponding quarter.

The improvement is mainly attributable to:-

- a) management's continuous efforts in cost cutting measures and by downsizing loss making operations
- b) suspension of the financial interest with effect from 1st Jan 2010 onwards as per "DRA" signed between the Group and Lenders.

Sales had increased by 40% from RM21.7mil in the preceding quarter ended 31 March 2010 to RM30.5mil for the current quarter under review.

The Group managed to record a marginal Profit before Tax for current quarter of RM0.3mil as compared to a pre-tax loss of RM2.4mil in the preceding quarter mainly due to higher sales registered in the current period.
