PBA Holdings Bhd is a public limited liability company, incorporated and domiciled in Malaysia and is listed on the Main Market of Bursa Malaysia Securities Berhad.

The Condensed Consolidated Interim Financial Statements of the Group as at and for the period ended 31 March 2014 comprise the Company and its subsidiaries (together referred to as the Group) and the Group's interests in joint venture entity.

These Condensed Consolidated Interim Financial Statements were authorized for issue by Board of Directors on 15 May 2014.

1. Basis of preparation

These condensed consolidated interim financial statements have been prepared in accordance with the applicable disclosure provisions of the Listing Requirements of Bursa Malaysia Securities Berhad and MFRS 134, *Interim Financial Reporting* in Malaysia and with IAS 34, *Interim Financial Reporting*. They do not include all of the information required for full annual financial statements, and should be read in conjunction with the consolidated financial statements of the Group as at and for the year ended 31 December 2013.

2. Significant accounting policies

The accounting policies adopted in the preparation of these condensed consolidation interim financial statements are consistent with those followed in the preparation of the Group's audited financial statements for the financial year ended 31 December 2013, except for the adoption of Amendments to Standards and Issue Committee (IC) Interpretations effective as of 1 January 2014.

12. Review of Group performance

Group revenue for the quarter ended 31 March 2014 increased by RM3.7 million or 6.0% as compared to the preceding year corresponding quarter 2013. The increase was mainly due to the increase in consumption of water. Group profit before tax of RM8.3 million decreased by 4.6% as compared to the preceding year corresponding quarter of RM8.7 million due to the increase in cost of sales.

13. Variation of results against preceding quarter

Group revenue increased from RM61.8 million to RM65.5 million as compared to the immediate preceding quarter. Group profit before tax of RM8.3 million was higher by RM6.4 million compared to the immediate preceding quarter of RM1.9 million largely due to higher revenue.

14. Current year prospects

Revenue from sales of water is expected to sustain for the year. Nevertheless, the Group continues with containment measures to mitigate escalating costs.

The term loan has been discounted using the prevailing financial rate of 5.5%. The fair value of the term loan was recognised as Deferred Income which will be amortised over 20 years period with effect from 14 September 2016.
