#### 1 CORPORATE INFORMATION

Ornapaper Berhad is a public listed liability company incorporated and domiciled in Malaysia, and is listed on Bursa Malaysia Securities Berhad.

These condensed consolidated interim financial statements were approved by the Board of Directors on 13 November 2017.

#### 2 BASIS OF PREPARATION

These condensed consolidated interim financial statements, for the year ended 30 September 2017, have been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad and also comply with IAS 34 Interim Financial Reporting issued by the International Accounting Standards Board.

The Group is principally involed in the manufacturing of corrugated board and carton and paper stationery product.

The Group's revenue and profit are mainly contributed by the corrugated board and carton segment.

The Corporate segment represents investment holding, the Group's management and treasury functions and transportation service.

There had been no material change in total assets and no differences in the basis of segmentation but there is significant increase of revenue and profit in the corrugated board and carton segment as compared to the last annual financial statement.

Performance review for financial period to-date

Corrugated board and carton segment :

The revenue increased by 20.38% from RM209,651 million to RM252,378 million which was mainly due to higher sales volume and higher unit selling price. In line with the increase in revenue, the profit after tax increased from RM7.748 million to RM11.264 million, representing a profit growth of 45.38%.

# Paper stationery products segment :

The revenue increased slightly by 7.42% from RM17.889 million to RM19.217 miillion.

In line with the increase in revenue, the segment registered a profit after tax of RM9,000 as compared to a loss of 376,000 registered in the last corresponding period.

7 SEASONALITY OF OPERATIONS

The business operations for the financial period to-date were not affected by seasonal or cyclical factors.

The Group recorded revenue growth of 31.51% to RM86.75 million compared to RM65.96 million recorded in the corresponding quarter due to higher sale orders received and higher average selling price. The sales volume and average selling price for corrugated cartons and boards has increased by 15.63% and 13.74% respectively compared to the corresponding quarter.

The key factors affect the group's performance include mainly raw material costs (such as kraft liner, test liner, medium paper and etc), operationg cost, demand for the packaging products and the ability to cope with the change. The recent upward trend of raw material costs has resulted in increase of production cost.

The Group recorded revenue growth of 6.23% to RM86.75 million compared to RM81.66 million recorded in the preceding quarter due to higher sale orders received and higher average selling price. The sales volume and average selling price for corrugated cartons and boards has increased by 2.92% and 3.22% respectively compared to the preceding quarter.

Despite the increase in revenue, profit before tax reduced from RM 5.30 million to RM 5.08 million. The decrease in profit was mainly due to higher cost of raw material & production cost. The average cost of raw material has increased by 8.41% compared to preceding quarter.

The Group is exposed to transactional currency risk primarily respective through sales and purchases that are denominated in a currency other than the respective functional currencies of the Group entities. The currencies giving rise to this risk are primarily United States Dollars ("USD") and Singapore Dollars ("SGD"). Such transactions are kept to an acceptable level and the Group only enters into foreign exchange contracts when necessary. The Group policy is not to speculate on such contracts.
