Performance review for financial period to-date

Corrugated board and carton segment:
The revenue decreased by 8.74% from RM257.15 million to RM234.67 million due to lower sales volume and lower average selling price.

Despite the decreased in revenue, profit after tax increased from RM9.18 million to RM9.75 million due to lower production and operational costs.

Paper stationery products segment :
The revenue increased slightly by 0.67% from RM11.83 million to RM11.91 million due to higher sales volume.

This segment recorded a loss after tax of RM1.56 million compared to RM0.466 million due to lower average selling price and higher operational costs.

The key factors affect the group's performance include mainly raw material costs (such as kraft liner, test liner, medium paper and etc), operationg cost, demand for the packaging products and the ability to cope with the change.

The Group's revenue increased by 32.62% to RM84.06 million compared to RM63.38 million recorded in the preceding quarter mainly due to higher sales volume generated in the current quarter under review resulted from pent-up sales after the lifting of the Movement Control Order (MCO). Economic activities were placed under strict Standard Operating Procedure ("SOP") which resulted in fewer deliveries to customers in the immediate preceding quarter.

In line with the increased in revenue, profit before tax increased from RM2.32 million to RM6.55 million.

The Industrial Court has dismissed the trade dispute pertaining the Collective Agreement on 1 June 2020, there are no further appeal and the matter had been concluded.
