#### 13.1 Opening and Closing of Application Lists

The Application Lists for the Offer will open at 10.00 AM on 22 August 2003 and will remain open until 8.00 PM on the same day or for such further period or periods as the Directors and/or Promoters of Luster together with the Managing Underwriter in their absolute direction may decide. Late applications will not be accepted.
