### 15. PROCEDURE FOR APPLICATION AND ACCEPTANCE

## 15.1 Opening and Closing of Applications

Applications will be accepted from 10.00 a.m. on 10 April 2004 to 5.00 p.m. on 23 April 2004 or such other later date or dates as the Directors of Mudajaya and the Underwriter may in their absolute discretion mutually decide. Late applications will not be accepted.

Should the closing date of the application be extended, the notice of such extension(s) will be advertised in a widely circulated Bahasa Malaysia and English newspaper in Malaysia.

## 15.2 Methods of Application

- (i) Application Forms; or
- (ii) Electronic Share Application.

### 15.3 Procedures for Application

### 15.3.1 Applications by Eligible Directors and Employees of the Mudajaya Group

Applications for 6,800,000 of the Issue Shares reserved for eligible Directors and employees of Mudajaya Group must be made on the Pink Application Forms provided only and not by way of other Application Forms or by way of Electronic Share Application.

### 15.3.2 Applications by the Malaysian Public

Applications for 8,600,000 of the Issue Shares made available for application by Malaysian citizens, companies, societies, co-operatives and institutions must be made on the White Application Forms provided or by way of Electronic Share Application.

### 15.3.3 Applications by Identified Investors

All investors for 9,504,000 of the Offer Shares under the private placement have been identified by the Placement Agent prior to the issuance of this Prospectus. Application procedures and terms and conditions for the allocation to the Bumiputera investors are set out in the separate letters/forms delivered to the respective Bumiputera investors.

Applications shall be made in connection with and subject to the terms of this Prospectus and the Memorandum and the Articles of Association of Mudajaya.

  out of or in connection with the contract between the parties and/or the
  Electronic Share Application scheme and/or any terms herein, all rights,
  obligations and liabilities shall be construed and determined in accordance
  with the laws of Malaysia and with all directives, rules, regulations and
  notices from regulatory bodies and that the Company irrevocably submits to
  the jurisdiction of the Courts of Malaysia.
- (m) The Directors of Mudajaya reserve the right to require any successful applicant to appear in person at the registered office of MIH within 14 days of the date of the notice issued to him to ascertain the regularity or propriety of the application. The Directors of Mudajaya shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant for the purpose of complying with this provision.

### 15.6 Applications and Acceptances

#### 15.7 CDS Accounts

Pursuant to Section 14(1) of the Securities Industry (Central Depositories) Act, 1991, MSEB has prescribed the securities of Mudajaya as Prescribed Securities. In consequence thereof, the IPO Shares issued/offered through this Prospectus will be deposited directly with the MCD and any dealings in these shares will be carried out in accordance with aforesaid Act and Rules of MCD.
