PART B - EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA

1. REVIEW OF PERFORMANCE

The Group's revenue for the three months ended 31 March 2011 was RM16.6 million compared to the preceding year's corresponding period of RM19.3 million. The decrease in revenue was mainly due to lower sale volume and lower sale margin affected by the adverse currency movement notably in the strengthening of Ringgit Malaysia against Euro and USD.

The loss before tax for the quarter was RM1.6 million compared to the preceding year's corresponding quarter of RM2.5 million. The decrease was attributable to the cost saving initiatives undertaken in administrative and selling functions.

2. MATERIAL CHANGES IN PROFIT BEFORE TAXATION FOR THE QUARTER REPORTED AS COMPARED WITH THE IMMEDIATE PRECEDING QUARTER

Loss before tax of the Group was RM1.6 million for the quarter ended 31 March 2011 compared to RM3.6 million for the preceding quarter ended 31 December 2010. The lower loss was due to the improved sale revenue against last quarter which was affected by low business activities during the year end break in Europe.

3. COMMENTARY ON PROSPECTS

The Group's export sales to European countries make up about 80% of the total revenue. With the on-going European sovereign debt crisis and the European Governments' implementation of fiscal austerity plan, operating environment in Europe will remain to be difficult and will continue to impact the demand for the Group's wood product.

Given the foregoing, the Group performances for the coming months will continue to be challenging in view of the present market conditions.

4. PROFIT FORECAST OR PROFIT GUARANTEE
