A. EXPLANATORY NOTES PURSUANT TO FINANCIAL REPORTING STANDARD 134, INTERIM FINANCIAL REPORTING AND BURSA LISTING REQUIREMENTS

A1. Basis of Preparation

The interim financial report has been prepared in accordance with the reporting requirements outlined in the MFRS 134 issued by the Malaysian Accounting Standard Board ("MASB") and the applicable disclosure provisions of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") and should be read in conjunction with the Group's annual audited financial statements for the year ended 31 December 2013.

The accounting policies and methods of computation adopted for the interim financial statements are consistent with those adopted for the annual audited financial statements for the year ended 31 December 2013.

The Group has adopted all the new and revised MFRSs and IC Interpretations that are relevant and effective for accounting periods beginning or after 1 January, 2013. The adoption of these new and revised MFRSs and IC Interpretations have not resulted in any material impact on the financial statements of the Group.

A2. Declaration of audit qualification

The preceding annual financial statements of the Group were reported on without any qualification.

A3. Nature and amount of unusual items

There were no extraordinary items for the current interim period.

A4. Seasonal or Cyclical Factors

There have been no material seasonal or cyclical factors affecting the results of the quarter under review.

A5. Material Changes in Estimates

There were no changes in estimates of amounts reported in prior financial years that have a material effect in the current quarter.

A6. Debts and Equity Securities

During the financial period, there were no issuances, cancellations, repurchases and resale of debts and equity securities. Total repayment of debts amounted to RM8.74 million for the reporting quarter.

A7. Dividend Paid

A single tier first and final dividend of 2.0 sen per ordinary share in respect of the financial year ended 31 December 2013 amounted to RM1,928,000.00 was paid on 1 August 2014.

Particleboard Manufacturing Sector

The revenue reported for the 9-month period increased by RM4.13 million or 3.28% as compared to the same period last year. The higher revenue achieved was mainly due to the sales of higher value and value added products. In addition, USD exchange rate to Ringgit was higher during this period as compared to last year.

The profit before tax reported for this period was RM10.67 million as compared to RM1.29 million in 2013, an increase of RM9.37 million or 724.27%, despite the increase in the electricity cost by about 19% effective January 2014. The much better profit performance was due mainly to the sales of higher value and value added products and the reduced interest cost derived from the pared down term loan facilities.

RTA Manufacturing Sector

The revenue reported for the 9-month period increased by RM20.25 million or 14.25 % as compared to last year. The continuous effort to automate its processes had achieved better productivity, efficiency and also the capability to produce higher value products.

The profit before tax reported for this period was RM11.75 million, a marginal decrease of RM0.25 million or 2.09% as compared to the same period last year.

B. ADDITIONAL INFORMATION REQUIRED BY BURSA MALAYSIA SECURITIES LISTING REQUIREMENTS

B1. Review of performance

The revenue of the Group for the current quarter ended 30 September 2014 was RM95.66 million, an increase of RM9.38 million or 10.87 % as compared with the corresponding quarter in 2013. For the 9 months ended 30 September 2014, there was an increase of RM22.88 million or 8.04 % as compared with the corresponding period. The increase was from both the particleboard and RTA sectors and the reasons for the increase are indicated in the Segmental Reporting A8.

The profit before taxation ("PBT") of the Group for the reporting quarter was RM6.30 million, an increase of RM0.25 million or 4.12 % as compared with the corresponding quarter in 2013 despite incurring an unrealized foreign exchange loss of about RM1.1 million in this reporting quarter due to the translation of the USD denominated loan. For the 9 months ended 30 September 2014, the Group achieved a PBT of RM23.05 million, an increase of RM8.91 million or 63.73 % over the corresponding period. There was a significant profit improvement in the particleboard sector due to better profit margin from the higher value products and the reduced interest cost due to the pared down term loans.

B2. Material change in profit before taxation for the quarter against the immediate preceding quarter

The Group reported a PBT of RM6.30 million for the current quarter as compared to RM8.97 million for the immediate preceding quarter ended 30 June 2014, a decrease of RM2.67 million or 29.77% due mainly to the RTA sector experiencing the off peak season in its main market, Japan.

B3. Prospect for the current financial year

The general business environment for both the particleboard and RTA sectors are stable and the Board is of the opinion that with all the various measures undertaken and barring unforseen circumstances, the Group is in the position to achieve better financial results this year.
