#### **Particleboard Manufacturing Sector**

The revenue and profit before tax reported for this period decreased by RM33.71 million or 24.08% and RM8.44 million or 80.11% respectively as compared to the same period last year. The lower revenue and profit before tax were mainly due to the soft particleboard market sentiment caused by the trade war between USA and China. Apart from this the major shut down for preventive maintenance of over 3 weeks during the early part of this year had also resulted in lower production and sales volumes.

#### **RTA Manufacturing Sector**

The revenue and profit before tax reported for this period increased by RM7.51 million or 4.11% and RM7.70 million or 1036.34% as compared to the same period last year. The higher revenue and profit before tax were mainly contributed by higher production efficiencies and better cost management resulting in lower operational costs. In addition, better USD/ MYR exchange had also impacted positively on the profit margin.

### **Fungi Cultivation**

The revenue reported for this period increased by RM0.37 million or 154.00% as compared to the same period last year. The higher loss before tax was due to higher expenses incurred to retrofit the production line and also higher R&D costs, marketing and promotional costs to create awareness of the eryngii mushroom in the local market.

There was no material event subsequent to the end of the period reported that had not been reflected in the financial statement for the said period.

### **B1.** Review of performance

The revenue and profit before tax of the Group for the current quarter ended 30 September 2019 were RM97.29 million and RM4.24 million, a decrease of RM4.42 million or 4.34% and an increase of RM0.85 million or 25.00% respectively as compared with the corresponding quarter in FYE 2018.

For the 9 months ended 30 September 2019, the revenue and profit before tax for the Group were RM297.25 million and RM8.82 million, a decrease of RM25.84 million or 8.00% and RM1.35 million or 13.30% respectively as compared to the corresponding period in FYE 2018.

The decrease was from the particleboard sector whereas RTA sector had increased and the reasons are stated in the Segmental Reporting A8.

## B2. Material change in profit before taxation for the quarter against the immediate preceding quarter

The Group reported a PBT of RM4.24 million for the current quarter as compared to RM1.03 million for the immediate preceding quarter ended 30 June 2019, an increase of RM3.21 million or 311.65% mainly due to the improved financial performance at both Particleboard and RTA sectors.

### B3. Prospect for the current financial year

The global business environment remains challenging as the macroeconomic conditions are highly uncertain with the trade war prevailing between US and China. The management of the particleboard sector will continue to focus on developing higher value products, better cost management and efficiencies.

As for the RTA sector, we are actively pursuing new product and market developments, further automation to improve productivity and efficiencies, better cost management and general improvements to the overall factory operations.

The Board is cautiously optimistic to face the challenges ahead.
