1. Corporate Information

BP Plastics Holding Berhad is a public limited liability company incorporated and domiciled in Malaysia and is listed on the Bursa Malaysia Securities Berhad.

These condensed consolidated interim financial statements were approved by the Board of Directors on 19 November 2012.

2. First-Time Adoption of Malaysian Financial Reporting Standards ("MFRS")

The condensed consolidated interim financial statements are unaudited and have been prepared in accordance with MFRS 134- *Interim Financial Reporting* and Paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad. The interim financial statements also comply with IAS 34- *Interim Financial Reporting* issued by the International Accounting Standards Board. For the periods up to and including the year ended 31 December 2011, the Group prepared its financial statements in accordance with Financial Reporting Standards ("FRS").

These interim financial statements are the Group's first MFRS interim financial statements for part of the period covered by the Group's first MFRS annual financial statements for the year ending 31 December 2012. MFRS 1- First-Time Adoption of Malaysian Financial Reporting Standards ("MFRS 1") has been applied

The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of changes in the financial position and performance of the Group since the year ended 31 December 2011.

In preparing its opening MFRS Statement of Financial Position as at 1 January 2011 (which is also the date of transition), the Group has adjusted the amounts previously reported in financial statements prepared in accordance with FRS. An explanation of how the transition from FRS to MFRS has affected the Group's financial position, financial performance and cash flows is set out in Note 3 below.

3. Significant accounting policies and application of MFRS 1

The audited financial statements of the Group for the year ended 31 December 2011 were prepared in accordance with FRS. Except for certain differences, the requirements under FRS and MFRS are similar. The significant accounting policies in preparing these condensed consolidated interim financial statements are consistent with those of the audited financial statements for the year ended 31 December 2011 except as follows:

(a) Business Combination

MFRS 1 provides the option to apply MFRS 3- *Business Combinations*, prospectively from the date of transition or from a specific date prior to the date of transition. This provides relief from full retrospective application of MFRS 3 which would require restatement of all business combinations prior to the date of transition.

Acquisition before date of transition

The Group has elected to apply MFRS 3 prospectively from the date of transition. In respect of acquisitions prior to the date of transition,

- (i) The classification of former business combinations under FRS is maintained;
- (ii) There is no re-measurement of original fair values determined at the time of business combination (date of acquisition); and
- (iii) The carrying amount of goodwill recognized under FRS is not adjusted.

(b) Property, plant and equipment

Upon transition to MFRS, the Group has elected to measure all its property, plant and equipment using the cost model under MFRS 116: *Property, Plant and Equipment*. At the date of transition to MFRS, the Group elected to regard the revalued amounts of land and buildings as at 31 December 2009 as deemed cost at the date of the revaluation as these amounts were broadly comparable to fair value at that date. The revaluation surplus of RM2,826,895 (30 September 2011: RM2,826,895; 31 December 2011: RM2,826,895) was transferred to retained earnings on date of transition to MFRS.

(c) Quoted equity instruments

Under FRS, the Group designated its investment in quoted equity instruments at fair value through profit or loss in accordance with FRS 139- *Financial Instruments: Recognition and Measurement.* Changes in fair value are taken to profit or loss. At the date of transition to MFRS, these quoted equity instruments were designated as available for sale.

(d) Foreign currency translation reserve

Under FRS, the Group recognized translation differences on foreign operations in a separate component of equity. Cumulative foreign currency translation differences for all foreign operations are deemed to be zero as at the date of transition to MFRS.

Other than as disclosed in Note 3(b) above, the transition from FRS to MFRS has no significant financial impact on the Group's financial position, financial performance and cash flows.

(e) Estimates

The estimates at 1 January 2011 and at 31 December 2011 were consistent with those made for the same dates in accordance with FRS. The estimates used by the Group to present these amounts in accordance with MFRS reflect conditions at 1 January 2011, the date of transition to MFRS and as of 31 December 2011.

10. Material events subsequent to the balance sheet date

11. Changes in the composition of the Group

There were no changes in the composition of the Group for the current quarter and financial period-to-date.

12. Changes in contingent liabilities or contingent assets

There were no changes in other contingent liabilities or contingent assets since the last annual statement of financial position as at 31 December 2011.

13. Review of performance

The Group recorded operating revenue of RM162.613 million for the 9 months ended 30 September 2012, a decreased of RM3.711 million (or 2.23%) from the RM166.324 million recorded in the same corresponding period last year. Overall revenue performance was marginally reduced due to a generally weak global economy plagued by persistent debt and unemployment woes, and the resulting slow consumer demand in the current year.

The 9 months unaudited profit before tax (PBT) was also lower at RM10.211 million, a reduction of 20.05% or RM2.561 million compared to the PBT of RM12.772 million in the same period last year. The lower PBT is due to higher material input and operating costs.

Unaudited profit after tax (PAT) for the period under review was RM7.672 million, which is RM3.584 million (or 31.84%) lower compared to cumulative PAT of RM11.256 million in same period last year. This was mainly attributable to lower GP margin coupled with a higher effective tax rate of 25% (compared to effective tax rate of 12% in the previous corresponding

period). The lower effective tax rate last year is due to the availability of tax reinvestment allowance incentives granted to a subsidiary, which has since been fully utilized.

14. Variation of results against last quarter

For the quarter ended 30 September 2012, operating revenue decreased by RM3.356 million (or 5.95%) to RM53.044 million from RM56.400 million in the preceding quarter, due mainly to lower average selling price.

The Group's unaudited profit before tax (PBT) and profit after tax (PAT) was not much changed at RM3.530 million and RM2.684 million respectively for the quarter under review, compared to the unaudited PBT and PAT of RM3.451 million and RM2.605 million respectively in the preceding quarter.

15. Current Year Prospects

Despite the Eurozone crisis having been contained and both US and China leadership transition already decided, the Group shall remain vigilant of the challenges posed by external economic and social-political factors both locally and overseas, while at the same time staying committed towards initiatives aimed at continuous improvement of our internal process efficiencies and productivity. With this in mind, the Board expects to deliver a lower profitable set of financial performance for the year ending 31 December 2012.

16. Variance of actual profit from profit forecast

This note is not applicable as the Group did not issue nor publish any profit forecast for the current quarter under review.
