EXPLANATORY NOTES TO THE QUARTERLY REPORT FOR THE PERIOD ENDED 30 SEPTEMBER 2007 (UNAUDITED)

A EXPLANATORY NOTES PURSUANT TO FRS 134

A1 BASIS OF PREPARATION

The quarterly financial report is unaudited and has been prepared in accordance with Financial Reporting Standard ("FRS") 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements should be read in conjuction with the audited financial statements for the year ended 31 December 2006. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Trust since the year ended 31 December 2006.

A2 CHANGES IN ACCOUNTING POLICIES

The significant accounting policies adopted are consistent with those of the audited financial statements for the year ended 31 December 2006.

Nevertheless, the FRS that will be effective in the annual financial statements for the year ended 31 December 2007 may be affected by the issue of additional interpretation(s) or other changes announced by the MASB subsequent to the date of issuance of this quarterly report. Therefore the policies that will be applied in the UOA-REIT's financial statements for the year cannot be determined with certainty at the date of issuance of this quarterly financial report.

A3 QUALIFIED AUDIT REPORT

The auditors' report on the financial statements for the year ended 31 December 2006 was not qualified.

A4 COMMENTS ON SEASONALITY OR CYCLICALITY OF OPERATIONS

The business operations of the Trust are not affected by material seasonal or cyclical factors.

A5 UNUSUAL ITEMS

There were no unusual items affecting assets, liabilities, unitholders' funds, net income or cash flows for the quarter under review.

A6 CHANGES IN ESTIMATES

There were no changes in estimates that have had a material effect in the current quarter results.

A7 DEBT AND EQUITY SECURITIES

There were no issuance, cancellation, repurchase, resale and repayment of debt and equity securities for the current quarter and period-to-date.

A8 INCOME DISTRIBUTION

The Trust had on 30 August 2007 paid an interim income distribution for the period ended 30 June 2007 amounting to RM10,059,302.

No income distribution was declared for the quarter under review but provision was made to distribute 95% of the income before tax (unaudited) for the quarter ended 30 September 2007 to be distributed by end of February 2008 as described under Section B12, Income Distribution.

A9 SEGMENTAL REPORTING

Not applicable.

A10 VALUATION OF PROPERTY, PLANT AND EQUIPMENT

There was no revaluation conducted on investment properties for the quarter under review.

There was no material event as at the latest practicable date from the date of this report.

A12 EFFECT OF CHANGES IN THE COMPOSITION OF THE TRUST

There was no changes in the composition of the Trust for the current quarter. The fund size stands at 245,948,700.

A13 CONTINGENT LIABILITIES OR CONTINGENT ASSETS

There were no contingent liabilities or contingent assets to be disclosed.

B EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD.

B1 REVIEW OF PERFORMANCE

For the quarter ended 30 September 2007, the Trust registered a total income of RM8,488,550 inclusive of interest income and other income of RM6,637 and RM37,944 respectively. Total expenditure for the quarter under review amount to RM3,177,341 with RM1,933,659 attributable to property operating expenses and RM1,243,682 attributable to non-property operating expenses. Income before taxation available for distribution for the quarter under review was RM5,311,209. Taking into consideration a 95% distribution, the Trust has set aside RM5,082,284 as provision for income distribution.

Against the corresponding quarter last year, gross rental has improved by approximately 5.93% or RM472,913, attributed mainly to the improvements in rental rate as well as contribution from the newly acquired property. Meanwhile, operating expenses has increased by approximately 9.98%, arising mainly from the maintenance costs of the new property (RM76,743), an allowance of doubtful debt amounting to RM35,260 (or approximately 0.4% of the gross rental) and increased manager's fee (RM80,869). The net improvement in realised income before taxation amounts to RM280,071 or approximately 5.6%.

Earnings per unit after manager's fee reduced by 0.27 sen or approximately 11% against the corresponding period last year, from 2.43 sen to 2.16 sen per unit. The reduction was contributed mainly by the reduction in the average occupancy of the investment properties resulted from space reconfiguration exercise during the current quarter as well as increased manager's fee.

B2 MATERIAL CHANGES IN INCOME BEFORE TAXATION FOR THE QUARTER AS COMPARED WITH THE IMMEDIATE PRECEDING QUARTER

There were no material changes in the income before taxation for the quarter under review.

B3 PROSPECTS

The Manager expects the properties to continue enjoying good occupancy and improvement in rental rates for the remaining part of the year (buoyed by a positive outlook in the commercial real estate in Malaysia).

The Manager will continue to adopt an active operating and capital management strategy to enhance the yields and returns to the existing Properties Parcels. The Manager will further seek opportunities to acquire real estate that meet the objectives of the Trust.

B4 VARIANCES

This is not applicable as there was no profit forecast or profit guarantee issued for this financial quarter.

- a) UOA Asset Management Sdn Bhd ("UOAAM"), the manager of UOA-REIT, has on 5 November 2007 received a letter of offer from UOA Holdings Sdn Bhd for the offer for sale of Wisma UOA Pantai by its' subsidiary, Magna Tiara Sdn Bhd, to UOA-REIT for a cash consideration of RM86,000,000.00. Wisma UOA Pantai is an office building with net lettable area of 157,481sq ft and 272 car park bays. The property is to be acquired free from encumbrances and subject to the terms and conditions to be stipulated in the Sale & Purchase Agreement to be executed. The offer is pending acceptance by UOAAM.
- b) UOAAM has on 7 November 2007 received and accepted an offer from Makmal Capital Sdn Bhd to purchase from UOA-REIT an office building namely Wisma UOA Bangsar for a total cash consideration of RM32,000,000.00. Wisma UOA Bangsar is an office building consist of 43,743 sq.ft net lettable area and 33 car park bays with the current net book value of RM21,650,000.00. Sale & Purchase Agreement has not been executed at the date of this report.

A provision was made to distribute RM5,082,284 as income distribution for quarter ended 30 September 2007. This translates into approximately 2.07 sen per unit for the quarter under review and includes a non-taxable portion of approximately 0.39 sen per unit (representing 18.84% of the gross distribution) deriving mainly from utilisation of capital allowance.

Pursuant to the amended Section 109D(2) of the Income Tax Act, 1967 and the announced Budget 2008, the following withholding tax rates would be applicable on distribution of income which is tax exempt at Trust's level (next income distribution falls on February 2008):

B14 PUBLIC SHAREHOLDING SPREAD

As at 30 September 2007, the Trust is not in compliance with paragraph 8.15 (1) of the Listing Requirement ("LR") of Bursa Malaysia Securities Berhad ("Bursa Securities"), which requires at least 25% of the total units of UOA REIT to be held by at least 1,000 public unitholders holding not less than 100 units each ("Public Shareholding Spread"). The non-compliance is mainly attributed to the reduction in the number of retail investors.

The Public Shareholding Spread based on the latest Records of Depositors of UOA-REIT as at 5 October 2007 stood at 29.57% with 975 public unitholders holding not less than 100 units.

The Trust is formulating and evaluating plans to rectify the Public Shareholding Spread via more investor relation activities particularly to retail investor. The Trust has not formulated timeline in respect of the rectification plan at the date of this report. A six (6) month extension of time for compliance has been granted by Bursa Securities to expire on 12 December 2007.
