# B. EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

## **B1.** Review of performance

The Group recorded revenue of RM35.21 million for the current quarter under review, representing an increase of 28% as compared to revenue of RM27.44 million for the corresponding period of the preceding financial year.

The Group registered a profit before tax of RM0.60 million for the current quarter under review as compared to loss before tax of RM4.42 million for the corresponding period of the preceding financial year due to higher sales, cost controls and lower provisions for doubtful debts.

## B2. Comparison with preceding quarter results

Revenue for the Group has decreased from RM42.00 million in the immediate preceding quarter to RM35.21 million in this quarter. Traditionally, the Group achieves its highest revenue in the fourth quarter, which is the immediate preceding quarter due to the celebrations of Mother's Day and Father's Day. The Group registered a profit before taxation of RM0.60 million as compared to profit before tax of RM3.72 million in the immediate preceding quarter as a result of lower sales and margins, and partial reversal of provisions for doubtful debts that has since been recovered in immediate preceding quarter.

## **B3.** Commentary on Prospects

Due to the uncertainties in the global economy, retail market conditions remain difficult. The Group will be cautious in managing these challenges as it focuses on executing its medium to long term growth strategies.

Barring unforeseen circumstances, the Group's performance is expected to be better than prior year.
