# NOTES TO THE INTERIM FINANCIAL REPORT FOR THE QUARTER ENDED 31 MARCH 2015

#### PART A – EXPLANATORY NOTES PURSUANT TO FRS 134

#### **1.** Basis of reporting preparation

The interim financial statements are unaudited and have been prepared in accordance with the requirement of Financial Reporting Standards 134 (FRS134): "Interim Financial Reporting" and Paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statement should be read in conjunction with the audited financial statements for the financial period ended 30 June 2014. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial period ended 30 June 2014.

The financial statements have been prepared on the assumption that the Group is a going concern. The Group incurred net losses during the financial period ended 30 June 2014 of RM1,217 million and, as of that date, the Group had net current liabilities of RM1,466 million and recorded capital deficiencies of RM821 million.

The Group was unable to meet its loan obligations during the financial period. As at 30 June 2014, the outstanding borrowings and bank overdrafts of the Group amounted to RM1,089 million.

On 26 November 2013 the Company announced that it became an Affected Listed Issue pursuant to Paragraph 2.1(e) and (f) of Practice Note N0.17/2011 ("PN 17") of the Main Market Listing Requirement of Bursa Malaysia Securities Berhad.

The Company is currently in the midst of preparing a debt restructuring scheme with a view to reaching an agreement with its lenders to restructure the defaulted debts of the Group. The proposed debt restructuring scheme is part of a restructuring exercise that the Company is currently formulating to address the Company's PN 17 status. The Company is required to submit its Proposed Regularisation Plan to the relevant authorities by 25 November 2014. On 9 January 2015 and 13 April 2015, Bursa Securites approved the Company's application for an extension of time up to 31 July 2015 to submit its Proposed Regularisation Plan to the regulatory authorities subject to the Requisite Announcement being made by 15 May 2015. On 13 May 2015, the Company submitted an application for extension of time of two (2) months up to 15 July 2015 to make the Requisite Announcement.

In addition, the major subsidiary of the Group, Perwaja Steel Sdn Bhd ("PSSB") has been granted an order pursuant to Section 176(1) and Section 176 (10) of the Companies Act, 1965 by the High Court of Malaya in Kuala Lumpur on 29 October 2013 to restrain all the further proceedings or the taking of any proceeding or action brought by any party including the scheme creditors for a period of 90 days effective from 29 October 2013. The above order was applied for in order to facilitate PSSB to convene a meeting with its creditors pursuant to Section 176 (10) of the Companies Act, 1965 for the purpose of considering and if thought fit, to approve with or without any alteration or modification, a proposed scheme of arrangement and compromise of PSSB. The subsidiary has been granted an extension of the Order on 27 January 2014, 25 July 2014, 21 January 2015, 21 February 2015 and 17 March 2015. On 17 March 2015, PSSB has been granted an extension of the Order pursuant to Section 176(1) and 176(10) of the Companies Act, 1965 by the High Court up till 21 August 2015.

In view of the matters set out above, there are material uncertainties that may cast significant doubt on the ability of the Group to continue as going concern.

The going concern assumption is highly dependent upon the successful restructuring of the defaulted debts, the successful approval and implementation of the Regularisation Plan, and the ability of the Group to attain profitable operations to generate sufficient cash flows to fulfil their obligations as and when they fall due. In the event that these are not forthcoming, the Group may be unable to realise their assets and discharge their liabilities in the normal course of business. Accordingly, the financial statements may require adjustments relating to the recoverability and classification of recorded assets and liabilities that may be necessary should the Group be unable to continue as going concern.

The financial statements of the Group does not include any adjustments and classifications relating to the recorded assets and liabilities that may be necessary if the Group is unable to continue as a going concern.

The significant accounting policies adopted are consistent with those of the audited financial statements for the financial period ended 30 June 2014 except for the adoption of the following new Amendments to FRSs and Interpretations for the current financial year ending 30 June 2015:-

Subsequently, this MFRS 9 was amended in year 2010 to include requirements for the classification and measurement of financial liabilities and for derecognition (known as MFRS 9 (2010)). Generally, MFRS 9 replaces the parts of MFRS 139 that relate to the classification and measurement of financial instruments. #### 2. Auditors' report

Due to the significance of the matters described in Note 1 Basis of Reporting Preparation, the Auditors have not been able to obtain sufficient appropriate audit evidence to provide a basis of an audit opinion. Accordingly, the Auditors do not express an opinion on the financial statements of preceding eighteen months audited financial statements ended 30 June 2014.

#### 3. Seasonal or cyclical factors

The business operation of the Group is generally affected by the demand in construction sector, commodities market condition and global economy, as well as the fourth quarter and first quarter festive seasons.

#### 4. Items of unusual nature and amount

There were no unusual items affecting assets, liabilities, equity, net income or cash flow of the Group during the current quarter and financial period.

#### 5. Material changes in estimates

There were no changes in the estimates of amount relating to the prior financial period that have a material effect in the current quarter under review.

#### 6. Debt and equity securities

There have been no issuances, cancellations, repurchases, resale and repayments of debt and equity securities during the current quarter and financial year.

### 7. Dividends paid

No dividend was paid during the financial year.

#### 8. Segmental information

Segmental information is not provided as the Group's primary business segment is principally in the manufacturing and trading in direct reduced iron, steel billets, beam blanks and blooms and its operation is principally located in Malaysia.

#### 9. Valuation of property, plant and equipment

There was no valuation of the property, plant and equipment in the current quarter under review.

#### **10.** Capital commitments

The total capital commitments being approved and contracted for as at the end of current quarter and financial year amount to RM58.6 million.

#### 11. Subsequent event

On 13 April 2015, the Company announced that Bursa Malaysia Securities Berhad had on 13 April 2015 approved its application for an extension of time up to 31 July 2015 to submit its regularisation plan to the regulatory authorities subject to the Requisite Announcement being made by 15 May 2015.

On 30 April 2015, the Company announced that on 30 April 2015, the following agreements were executed:

- (a) A Second Memorandum of Agreement between Perwaja and Zhiyuan to formalize the parties' agreement to revamp and restart the Kemaman Plant pending the procurement of all requisite approvals to implement Perwaja's Proposed Regularisation Scheme; and
- (b) A Lease Agreement between Perwaja Steel Sdn Bhd ("PSSB"), a wholly-owned subsidiary of Perwaja and Zhiyuan in relation to the lease by PSSB of a portion of the land forming the Kemaman Plant to Zhiyuan.

On 14 May 2015, the Company announced that it had on 13 May 2015 submitted an application for extension of time of two (2) months up to 15 July 2015 to make Requisite Announcement.

#### <u>Claim I</u>

(i)

Claims have been made by two suppliers on the non-performance of the Contract of Affreightment. As at the date of this report, the Management is not aware of any legal proceedings being instituted by the suppliers against the subsidiary.

#### <u>Claim II</u>

A claim has been made by a supplier for compensation on the breach of the Supply Agreement and Kiln Management Agreement. The Court has fixed the case management on 24 August 2015.

#### <u>Claim III</u>

A financier issued a claim on the subsidiary and the Company as guarantor for the outstanding amount including interest. As at the date of this report, the Management is not aware of any legal proceedings being instituted by the financier against the subsidiary or the Company.

#### (ii) Proposed Retrenchment Programme

On 15 December 2014, the Company issued an announcement on clarification to an article titled "Perwaja to close shop, lay off 1,500" published by the New Straits Times on 12 December 2014.

The Company clarified that its wholly-owned subsidiary, PSSB has in fact ceased all material operations since August 2013 when its dry gas and electricity supplies were curtailed. Given the cessation of operations, PSSB intends to undertake a company-wide retrenchment programme for its employees ("Proposed Retrenchment Programme").

As at the date of this announcement, PSSB has no employees under its employment as the employees were retrenched pursuant to the retrenchment notice dated 17 November 2014.

The compensation scheme in relation to the Proposed Retrenchment Programme was formulated under professional advice and the estimated financial impact of RM55.1 million was reflected in the financial statements for the quarter and period ended 31 March 2015.

# PART B: EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

#### 14. Review of performance of the Company and its principal subsidiaries

For the current quarter under review, the Group reported a revenue of RM0.2 million and a pre-tax loss of RM119.6 million. The financial year end of the Company has been changed from 31 December to 30 June to cover the 18-month period from 1 January 2013 to 30 June 2014 and thereafter, to end on 30 June each year. Accordingly, there are no corresponding quarter for the preceding year.

The low revenue and pre-tax loss in the current quarter was mainly due to zero production and low sales volume. The zero production was affected by the gas and electricity supply curtailment by Petronas and TNB at the material time. This resulted in PSSB's inability to secure the necessary working capital for resumption of production.

# **15.** Material changes in profit before tax for the current quarter results compared to the results of the preceding quarter

The Group recorded a pre-tax loss of RM119.6 million as compared to the preceding quarter's pretax loss of RM69.2 million. The higher pre-tax loss in the current quarter is mainly due the accrual for staff retrenchment expenses of RM55.1 million.

#### 16. Prospects for the financial year ending 30 June 2015

On 26 November 2013, the Company was designated an Affected Listed Issuer under Practice Note ("PN") 1 and PN 17 of the Bursa Malaysia Securities Berhad's Main Market Listing Requirements ("the MMLR"). Accordingly, the Company is required to inter alia submit a regularisation plan to the relevant authority within 12 months from the date of such announcement. The Company is currently in the process of formulating such Regularisation Plan. The Company is required to submit its Proposed Regularisation Plan to the relevant authorities by 25 November 2014. On 9 January 2015 and 13 April 2015, Bursa Securites approved the Company's application for an extension of time up to 31 July 2015 to submit its Proposed Regularisation Plan to the regularisation Plan to the regulatory authorities subject to the Requisite Announcement being made by 15 May 2015. On 13 May 2015, the Company submitted an application for extension of time of two (2) months up to 15 July 2015 to make the Requisite Announcement.

The Group is undertaking a debt restructuring exercise to address its liquidity issue. The Group's prospect is highly dependent on the following successful events:

- i) approval of the restructuring scheme by the scheme creditors;
- ii) negotiation with secured lenders and Government of Malaysia; and
- iii) implementation of the restructuring scheme.

In view of the above, the prospects will continue to be challenging.

#### 17. Variance between Actual Profit and Forecast Profit

The Group did not issue any profit forecast in a public document during the current financial period.

#### 18. Taxation

The Group's effective tax rate for the current quarter and financial period is higher than the prevailing statutory tax rate of 25%, mainly due to non-recognition of deferred tax assets arising from tax losses in the current quarter and financial period.

On 26 September 2013, the Group obtained approval from CDRC to mediate with the financial lenders of the Group for the purpose of debt restructuring exercise with the financial lenders.

#### Restraining Order under Section 176 (10) of the Companies Act, 1965

The major subsidiary of the Group, PSSB has been granted an order pursuant to Section 176(1) and Section 176 (10) of the Companies Act, 1965 by the High Court of Malaya in Kuala Lumpur on 29 October 2013 to restrain all the further proceedings or the taking of any proceeding or action brought by any party including the scheme creditors for a period of 90 days effective from 29 October 2013. The above order was applied for in order to facilitate PSSB to convene a meeting with its creditors pursuant to Section 176 (10) of the Companies Act, 1965 for the purpose of considering and if thought fit, to approve with or without any alteration or modification, a proposed scheme of arrangement and compromise of PSSB. The subsidiary has been granted an extension of the Order on 27 January 2014, 25 July 2014, 21 January 2015, 21 February 2015 and 17 March 2015. On 17 March 2015, PSSB has been granted an extension of the Order pursuant to Section 176(1) and 176(10) of the Companies Act, 1965 by the High Court up till 21 August 2015. Save that the Order shall not be applicable against, RHB Bank Berhad, Standard Chartered Bank Malaysia Berhad, Kuwait Finance House (Malaysia) Berhad, OCBC Bank (Malaysia) Berhad, Tenaga Nasional Berhad, Petroliam Nasional Berhad, Government of Malaysia and Orix Credit Malaysia Sdn Bhd.
