

PART A – EXPLANATORY NOTES PURSUANT TO THE FINANCIAL REPORTING STANDARDS ("FRS") 134: INTERIM FINANCIAL REPORTING

1. Basis of Preparation

The interim financial report is unaudited and has been prepared in accordance with the requirements of FRS 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements.

The interim financial report should be read in conjunction with the proforma consolidated financial information and the Accountants' Report for the financial year ended 30 June 2009 as disclosed in the Prospectus of the Company dated 3 December 2009 and the accompanying explanatory notes attached to the interim financial report.

These explanatory notes attached to the interim financial report provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Company and its subsidiaries ("Group") since the financial year ended 30 June 2009.

In conjunction with our listing on the Main Market of Bursa Securities, the Group's financial statements have adopted the merger accounting method.

2. Summary of significant accounting policies

Significant accounting policies adopted are consistent with the Proforma Consolidated Financial Information and the Accountants' Report for the financial year ended 30 June 2009 as disclosed in the Prospectus dated 3 December 2009. 3. Auditors' Report on Preceding Annual Financial Statements

The auditors' report on the financial statements of the Group for the financial year ended 30 June 2009 was not subject to any audit qualification.

The business operations of the Group are generally in the retail sector, which are subject to seasonal variations such as major local festive seasons, school holidays, and carnival sales.

There was no item, which is unusual because of their nature, size or incidence that has affected the assets, liabilities, equity, net income or cash flows of the Group for the current financial quarter under review.

6. Material Changes in Estimates

There were no changes in estimates of amounts that have had a material effect in the current financial quarter results.

7. Dividends Paid

No dividend was proposed or paid during the current financial quarter under review.

8. Valuation of Property, Plant and Equipment

The valuations of property, plant and equipment have been brought forward without amendment from the audited financial statements for the financial year ended 30 June 2009.



9. Debt and Equity Securities

Save as disclosed below, there were no issuance, cancellation, repurchase, resale or repayment of debt and/or equity securities, share buy-backs, share cancellations, shares held as treasury shares and resale of treasury shares for the current financial quarter under review:

The initial public offering of YOCB's new ordinary shares of RM0.50 each ("YOCB Shares") at an issue price of RM0.88 per share comprising the public issue and offer for sale, collectively ("IPO") when completed on 23 December 2009, the entire issued and paid up share capital of the Company comprising 120,000,000 YOCB Shares will be listed on the Main Market of Bursa Securities.

The details of the IPO as disclosed in the prospectus dated 3 December 2009 are as follows:

(a) Public Issue

The public issue of 25,170,740 new YOCB Shares at an issue price of RM0.88 per YOCB Share comprising:

- (i) 6,000,000 new YOCB Shares available for application by the Malaysian Public;
- (ii) 6,500,000 new YOCB Shares available for application by eligible directors, employees and other persons who have contributed to the success of the Group; and
- (iii) 12,670,740 new YOCB Shares available by way of private placement to selected investors.

(b) Offer for Sale

The offer for sale of 25,229,260 YOCB Shares at an offer price of RM0.88 per YOCB Share payable in full on application comprising:

- (i) 12,000,000 YOCB Shares by way of placement to Bumiputera Investors approved by the Ministry of International Trade and Industry; and
- (ii) 13,229,260 YOCB Shares by way of placement to selected investors.

- (iv) Monsieur (M) Sdn Bhd ("MSB") for the purchase consideration of RM744,835 by an issuance of 1,489,670 new YOCB Shares at par value.

1. Review of Performance of the Group

The Group has recorded a revenue and profit before tax of approximately RM30.86 million and RM4.55 million respectively for the current financial quarter under review.

2. Material Changes in the Quarterly Results as Compared to the Results of the Immediate Preceding Quarter

No comparative figures are presented for the immediate preceding quarter as this is the first consolidated results of the Group being prepared by the Company subsequent to the acquisition of the entire issued and paid-up share capital of SYOSB, SFSB, ETHSB and MSB on 11 August 2009.

3. Prospects for the Current Financial Year

The recovery in the global financial crisis is still uncertain and the local retail market will remain challenging and competitive in moving forward. However, with the Group's underlying fundamental strength of efficient business operations, financial stability and wide distribution network, the Board expects a satisfactory growth in the financial performance of the Group for the financial year ending 30 June 2010, with plans and strategies already in place to weather these challenging times.

4. Profit Forecast or Profit Guarantee

The Group has not issued any profit forecast or profit guarantee for the current financial quarter under review or in its prospectus dated 3 December 2009.

(a) IPO

On 3 December 2009, the Company issued a prospectus for the public issue of up to 25,170,740 new YOCB Shares at an issue price of RM0.88 per ordinary share payable in full on application in conjunction with its listing on the Main Market of Bursa Securities.

The entire enlarged issued and paid-up share capital of RM60,000,000 comprising of 120,000,000 ordinary shares of RM0.50 each of the Company is expected to be listed on the Main Market of Bursa Securities on 23 December 2009.

(b) Utilisation of proceeds

The gross proceeds from the public issue of approximately RM22.15 million shall be utilised in the following manner:

11. Changes in Material Litigation

On 13 August 1998, SYOSB and YFR, filed a suit at the High Court of Malaysia in Kuala Lumpur against Agenda Istimewa Sdn Bhd ("Agenda") for the refund of the deposit in the sum of RM520,150 together with the interest at the rate of 12% per annum, general damages and a declaration that the sale and purchase agreements entered into between SYOSB and Agenda and between YFR and Agenda for the purchase of four (4) industrial lots by SYOSB and one (1) industrial lot by YFR from Agenda were lawfully terminated and/or rescinded.

The trial of the suit was completed on 4 August 2009 and the Court delivered its decision on 27 October 2009. The Court dismissed the suit by SYOSB and YFR with costs and allowed Agenda's counter-claim for a declaration that the sale and purchase agreements were lawfully terminated and/or rescinded by Agenda and awarded in favour of Agenda special damages of RM520,150, general damages for breach of contract, and 8% interest per annum on the sum due and payable to Agenda and costs.

On 28 October 2009, SYOSB and YFR had given instructions to their solicitors to file an appeal and stay of proceedings against the High Court Judge's decision dated 27 October 2009. The Notice of Appeal was filed at the Court of Appeal on 10 November 2009. However, the hearing date of the Appeal has not been fixed by the Court of Appeal.

On 12 November 2009, an application for the Stay of Execution of Judgment was filed in the High Court. The High Court has fixed a case management of the same on 8 January 2010. The hearing date of the said application will be fixed on 8 January 2010.

Save as disclosed above, there is no material litigation pending as at the date of this announcement.

12. Dividend

The Board does not recommend any interim dividend for the current financial quarter under review.

The basic earning per share has been calculated by dividing the Company's profit for the current financial quarter and current financial year to-date by the number of ordinary shares in issue during the current financial quarter and current financial year to-date under review.
