NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED INTERIM FINANCIAL STATEMENTS

PART 1-Explanatory Notes Pursuant to FRS 134

A1. Turbo-Mech Berhad is a public limited liability company incorporated and domiciled in Malaysia, and is listed on Bursa Malaysia Securities Berhad.

These condensed consolidated interim financial statements were approved by Board of Directors on 20 May 2016.

A2. Basis of Preparation

The condensed consolidated interim financial statements of the Group for the first quarter ended 31 March 2016, have been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of the Bursa Malaysia Securities Berhad. These condensed consolidated interim financial statements also comply with IAS 34 Interim Financial Reporting issued by the International Accounting Standards Board.

The condensed consolidated interim financial statements should read in conjunction with the audited financial statements for the year ended 31 December 2015.

The explanatory notes attached to these condensed consolidated interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2015.

A3. Significant accounting policies

PART B – Explanatory Notes Pursuant to Appendix 9B of the Listing Requirements of Bursa Malaysia

B1. Analysis of Performance

The Group achieved revenue of RM6.7 million for the current quarter, a decrease of RM0.9 million or 12% as compared to the RM7.6 million achieved during the preceding year corresponding quarter. The decrease in revenue was mainly due to drop in sales in Singapore region.

The Group achieved gross profit of RM1.6 million during the current quarter. This represent a decrease of RM2.1 million or 56.8% as compared to the RM3.7 million achieved during the preceding year corresponding quarter. The gross profit margin for this quarter is 23.9% which is lower than the gross profit margin of 48.7% achieved during the preceding year corresponding quarter, resulting from cost down pressure from customers.

For the current quarter, the Group recorded a loss after tax of RM0.24 million, compared against the preceding year corresponding quarter profit after tax of RM2.5 million. The decrease was mainly due to the reduction in revenue and lower gross profit margin.

The Group achieved revenue of RM6.7 million for the current quarter, a decrease of RM1.51 million or 18.4% as compared to the RM8.22 million achieved during the previous quarter.

The Group recorded a loss before tax of RM0.22 million during the current quarter, compared to profit before tax of RM1.55 million achieved during the previous quarter. This is due to decrease in revenue and profit margin during the quarter.

For the current quarter, the Group recorded a loss after tax of RM0.24 million, compared against the previous quarter profit after tax of RM1.36 million.



B3. Prospects

The demand for petrochemical industries products are influenced by the market economic conditions. As a supplier of pumps and compressors to both upstream as well as downstream of petrochemical industries, the demand for our products and services will inevitably be affected as well.

The Company will stay focused on maintenance and services and will stay relevant to the industry.

The Group has not issued any profit forecast or profit guarantee for the current financial quarter under review.
