A EXPLANATORY NOTES PURSUANT TO MFRS 134 INTERIM FINANCIAL REPORTING

A1 Basis of preparation

B EXPLANATORY NOTES PURSUANT TO PARAGRAPH 9.22 OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

B1 Review of performance

For the quarter ended 30 June 2016, APFT Berhad and its subsidiaries ("APFT Group" or "Group") generated revenue of RM3.749 million and loss before taxation ("LBT") of RM0.565 million as compared to revenue of RM12.862 million and loss before taxation of RM2.782 million in the preceding year corresponding quarter ended 30 June 2015 respectively. The decrease in revenue by RM9.113 million for the current financial quarter under review as compared to the preceding year corresponding quarter was mainly due to decrease in contribution from PT Technic (M) Sdn Bhd ("PTTSB"). The loss before tax of RM0.565 million was mainly due to decrease in revenue.

Pursuant to the change of financial year from 31 March 2016 to 31 July 2016, no comparative figures are presented.

B2 Variation of results against preceding quarter

The Group registered a revenue of RM3.749 million for the current quarter under review representing a decrease of RM91.13 million from the RM12.862 million in the preceding quarter. The Group's loss before tax was RM3.769 million for the current quarter under review as compared to loss before tax of RM6.755 million in the preceding quarter.

The decrease in revenue is mainly due to an decrease from flight education and training segment while the increased in loss before tax is mainly due to the decrease in revenue.

B3 Prospects

The Flight Training Academy has been focusing on Helicopter Training and currently is training BOMBA cadets. There is possibility of getting other agencies to send their staff to train in the helicopter licence program.

The contract with MOE for the Diploma Vocational Malaysia (DVM) is ongoing and we were given additional students for year 2016 and can expect more in 2017. The SKM programs have been given approval by the HRDF to conduct courses under the 1M GRIP and the marketing for this program has started.

Maintenance Training Academy has been conducting training for a client in Abu Dhabi and the client has requested to send their students to us for the EASA CAT A program.

With the Government's "Transformasi" program in education to go towards TVET we have been identified as a partner and collaborator in Aviation training with our University partners.

B4 Profit forecast and profit guarantee

The Group has not issued any profit forecast or profit estimate for the current financial quarter under review or in any public documents.

B11 Material litigations

Save as disclosed below, the Company and its subsidiary companies are not engaged in any material litigation, claims or arbitration, either as plaintiff or defendant as at the date of this report:-

- i) PT Technic (M) Sdn Bhd (PTTM), a 51% owned subsidiary company of APFT Berhad was served on 4 August 2015 with a Writ of Summons by Shamira Sdn Bhd (Plaintiff) whereby the Plaintiff alleges that PTTM owes a sum of RM783,527.30 to the Plaintiff being the outstanding payment as at 30 June 2015 for services rendered by the Plaintiff pursuant to a letter of award dated 16 April 2014.
 Settlement has been agreed between both parties.
- ii) PTTM received a letter of demand dated 28 July 2015 from the solicitors of Saboleh Cemerlang Sdn Bhd alleging that a sum of RM478,529.64 is due and owing to Saboleh Cemerlang Sdn Bhd in respect of goods sold and delivered. Legal proceedings have yet to be initiated by Saboleh Cemerlang Sdn Bhd. Our Directors are of the view that there is a strong possibility for PTTM to amicably settle this matter. The estimated maximum exposure to liabilities is RM478,529.64 together with interest, if any, and legal costs.

The Plaintiff has officially withdraw the case on 20 January 2016.

iii) In 2012, Asia Pacific Flight Training Academy Limited (APFTAL) filed a writ petition ("2012 Writ") againts (1) the Union of India, (2) the Director General of Civil Aviation of India, (3) the Commissioner of Customs of India, (4) the Deputy Commissioner of Customs of India, and (5) the Assistant Commissioner of Customs of India (hereinafter collectively referred to as "Respondents") for not releasing the aircrafts, imported by APFTAL for purposes of their flight training purposes ("Aircraft"), with "nil" duty as being illegal, arbitrary and unconstitutional at the High Court of Judicature at Hyderabad, India ("HCJH"). Vide an order dated 10 March 2015, the HCJH ordered inter alia for the Respondents to dispose the said proceedings pursuant to the show couse notice dated 21 September 2012 issued by the 5th Respondent after granting opportunity to APFTAL to be heard and for the release of the Aircrafts by the acceptance of a bank guarantee amounting to Indian Rupee ("Rs.") 67,32,364 ("BG") (equivalent to approximately RM409,960.57 based on the exchange rate of Rs. 100: RM6.0894, being the middle rate quoted by Bank Negara Malaysia as at 5.00 p.m. on the 17 March 2016) to be furnished by APFTAL. APFTAL furnished the BG for the release of the Aircrafts and further challenged the show couse notice. On 11 June 2015, the Deputy Commissioner of Customs passed an order under the Customs Act 1962, rejecting the contentions of APFTAL on untenable grounds and holding that APFTAL is not entitled to the exemptions granted ("2015 Order"). APFTAL has filed an appeal to the Commissioner (Appeals), Customs to set aside the 2015 Order, and therefore exempting APFT from payment of the assessed duty amounting to Rs. 67,32,364 (equivalent to approximately RM409,960.57 based on the exchange rate of Rs. 100: RM6.0894, being the middle rate quoted by Bank Negara Malaysia as at 5.00 p.m. on the 17 March 2016) along with interests.

APFTAL had in June 2015 filed a writ petition W.P. No 17973 of 2015 againts the Respondents challenging the action of the 4th Respondent for encashing the BG even before APFTAL could file an appeal or seek a stay of the 2015 Order. APFTAL is currently awaiting the hearing of the writ.

The Directors of APFTAL are of the view there is a possibility for the Respondents to restore the BG. The estimated maximum exposure to liabilities is interest, if any, and legal costs.

iv) The Board of Directors of APFT Berhad announced that Asia Pacific Flight Training Sdn Bhd (APFTSB), an indirect wholly owned subsidiary of APFT Berhad, received a Notice of Appointment of Receiver and Manager (R&M) dated 24 August 2016 by Kuwait Finance House (Malaysia) Berhad.

APFTSB have already put into place a plan to fulfil its obligations to the creditor that appointed the R&M by disposing some of the assets in the Group as well as assets in the executive director's personal company. The funds that have been earmarked for payment from the assets disposal should be in by end of September. The group will cooperate with the R&M who will be monitoring the status of the said funds.
