PART A -

EXPLANATORY NOTES PURSUANT TO THE MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134: INTERIM FINANCIAL REPORTING

A1. Basis of Preparation

These condensed consolidated interim financial statements, for the period ended 30 June 2014, have been prepared in accordance with MFRS134: Interim Financial Reporting and paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities"). These condensed consolidated interim financial statements also comply with IAS34: Interim Financial Reporting issued by the International Accounting Standards Board.

The explanatory notes attached to the unaudited interim financial report provide an explanation of the event and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the year ended 31 December 2013. They do not include all the information required for full annual financial statements and should be read in conjunction with the Group's financial statements for the financial year ended 31 December 2013.

PART B -

ADDITIONAL INFORMATION AS REQUIRED BY LISTING REQUIREMENT OF BURSA MALAYSIA SERCURITIES BERHAD (PART A OF APPENDIX 9B)

B1. Review of performance of the Group

The Group recorded revenue of RM37.28 million (which consists of RM37.23 million from the manufacturing segment and RM0.05 million from the electricity segment respectively) during the current quarter under review, a decrease of approximately RM1.96 million as compared to a revenue of RM39.24 million (which consist of RM39.22 million from the manufacturing segment and RM0.02 million from the electricity segment respectively) recorded in the corresponding quarter last year. Decrease in sales was mainly due to lower sales volume recorded in current quarter under review.

The profit before tax of the Group for the current quarter under review was RM3.78 million, an increase of approximately RM1.15 million as compared to the preceding year's corresponding quarter ended 30 June 2013. Higher average selling price has improved the profit margin and profit before tax in current quarter under review. This is mainly arises from stronger USD exchange rate in current quarter as compared to exchange rate in corresponding quarter of preceding year. Besides, higher interest income also contributes to higher profit before tax in current quarter under review. Profit of the Group for 3-month ended 30 June 2014 amounted to RM3.55 million.

B2. Comparison with immediate preceding quarter's results

The Group's revenue for the current quarter under review decreased slightly by RM0.54 million as compared to the revenue of RM37.82 million in the immediate preceding quarter, which was mainly due to lower sales volume.

The profit before tax for the current quarter under review of RM3.78 million has decreased by RM0.86 million in comparison to the immediate preceding quarter of RM4.64 million. Lower sales profit margin due to increasing logs price and weakening of USD dollar since end of March 2014 are the main factors of lower profit before tax in current quarter under review.

B3. Prospects for the remaining period of current financial year

Increasing production costs and weakening of US dollars recently had reduced the profit margin of our products. Albeit the challenges in this industry which includes inter-alia, logs supplies, the Board is nevertheless positive of the prospects for the remaining period of current financial year.

Addition and improvement to the machineries and equipments in this year had improved the production recovery rate of veneer sheets and plywood, indirectly reducing our production cost per cubic metre to offset the impact of increasing production costs. The Board will continue to work on improving operational efficiency by enhancing the productivity of its workforces and its machineries.

The purpose of entering foreign currency forward contracts is to minimise the impact of unfavourable movement in exchange rate on the trade receivables and bank balances denominated in US Dollar.

The market risk posed by the Group's foreign currency forward contracts depends on the economic changes that may impact market prices. As the exchange rate is pre-determined under such contracts, the market risk in these instruments is not significant. The foreign currency forward contracts are transacted with the Group's banker and the credit risk for non-performance by the counterparty in these instruments is minimal.

Basic earnings per share are calculated by dividing the profit for the period, net of tax, attributable to owners of the parent by the weighted average number of ordinary shares in issue during the period. There is no dilutive effect.
