PART A -

EXPLANATORY NOTES PURSUANT TO THE MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134: INTERIM FINANCIAL REPORTING

A1. Basis of Preparation

These condensed consolidated interim financial statements, for the period ended 30 September 2014, have been prepared in accordance with MFRS134: Interim Financial Reporting and paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities"). These condensed consolidated interim financial statements also comply with IAS34: Interim Financial Reporting issued by the International Accounting Standards Board.

The explanatory notes attached to the unaudited interim financial report provide an explanation of the event and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the year ended 31 December 2013. They do not include all the information required for full annual financial statements and should be read in conjunction with the Group's financial statements for the financial year ended 31 December 2013.

PART B -

ADDITIONAL INFORMATION AS REQUIRED BY LISTING REQUIREMENT OF BURSA MALAYSIA SERCURITIES BERHAD (PART A OF APPENDIX 9B)

B1. Review of performance of the Group

The Group recorded revenue of RM33.93 million (which consists of RM33.89 million from the manufacturing segment and RM0.04 million from the electricity segment respectively) during the current quarter under review, a decrease of approximately RM3.43 million as compared to a revenue of RM37.36 million (which consist of RM37.33 million from the manufacturing segment and RM0.03 million from the electricity segment respectively) recorded in the corresponding quarter last year. Decrease in sales was mainly due to lower sales volume as well as lower average selling price recorded in current quarter under review.

Profit before tax of the Group in current quarter was RM3.26 million, a decrease of approximately RM2.42 million as compared to the preceding year's corresponding quarter. This was mainly due to lower sales volume and decreasing gross profit margin in current quarter under review. In addition, there was also a one-time gain in relation to the advance payment of levy which was included in the results of corresponding quarter of the previous financial year of RM0.54 million, which is no longer recurring in the current quarter. Lower average selling price and higher production cost per cubic metre has affected the profit margin of our products in current quarter under review. Lower average selling price is mainly arises from lower USD exchange rate in current quarter as compared to exchange rate in corresponding quarter of preceding year. On the other hand, production cost per cubic metre had increased moderately due to lower production volume as a result of shortage in manpower. Profit of the Group for 3-month ended 30 September 2014 amounted to RM3.32 million.

B2. Comparison with immediate preceding quarter's results

The Group's revenue for the current quarter under review decreased by RM3.35 million as compared to the revenue of RM37.28 million in the immediate preceding quarter, which was mainly due to lower sales volume.

The profit before tax for the current quarter under review of RM3.26 million has decreased by RM0.52 million in comparison to the immediate preceding quarter of RM3.78 million. This was mainly due to lower sales volume in current quarter under review as well.

B3. Prospects for the remaining period of current financial year

Increasing production costs per cubic metre due to lower production volume had reduced the profit margin of our products. The Board expects that the operating environment in the remaining period of the current financial year will remain tough and challenging. The Board will continue to work on improving operational efficiency by enhancing the productivity of its workforce and its equipment fleet.

B4. Profit forecast or profit guarantee

The Group did not issue any profit forecast or profit guarantee in the current quarter or in the prior financial year.

The purpose of entering foreign currency forward contracts is to minimise the impact of unfavourable movement in exchange rate on the trade receivables and bank balances denominated in US Dollar.

The market risk posed by the Group's foreign currency forward contracts depends on the economic changes that may impact market prices. As the exchange rate is pre-determined under such contracts, the market risk in these instruments is not significant. The foreign currency forward contracts are transacted with the Group's banker and the credit risk for non-performance by the counterparty in these instruments is minimal.

The fair value of derivative liabilities as at 30 September 2014 amounting to RM796,000 has been recognised in the financial statements.

B11. Earnings per share

Basic earnings per share are calculated by dividing the profit for the period, net of tax, attributable to owners of the parent by the weighted average number of ordinary shares in issue during the period. There is no dilutive effect.
