PART A – EXPLANATORY NOTES PURSUANT TO THE MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134: INTERIM FINANCIAL REPORTING

A1. Basis of Preparation

The condensed consolidated interim financial statements are unaudited and have been prepared in accordance with the requirements of Malaysian Financial Reporting Standard 134 ("MFRS 134"): Interim Financial reporting and Appendix 9B part A of paragraph 9.22 of the Main Market Listing Requirements ("Listing Requirements") of Bursa Malaysia Securities Berhad ("Bursa Securities"). B1. Performance Review

Current quarter against corresponding quarter in prior year

The Group achieved revenue of RM24.50 million and recorded a loss before tax of RM0.08 million for the current quarter as compared to revenue of RM25.40 million and profit before tax of RM0.02 million for the corresponding quarter in prior year.

B2. Comment on Material Change in Profit before Taxation Against Immediate Preceding Quarter

The Group achieved revenue of RM24.50 million and recorded a loss before tax of RM0.08 million for the current quarter as compare to revenue of RM21.13 million and profit before tax RM0.17 million for immediate preceding quarter.

The loss before tax for the current reporting quarter is mainly due to fluctuation in foreign currency exchange rate.

B3. Commentary on Prospects

The Group expects to continue to face the challenging economic and business environment in the coming quarters. The global economic downturns, stiff competitions, fluctuations in lead prices and volatility of foreign currency exchange rate will affect the Group's overall performance. Nonetheless, the Group is confident that through continuous improvement in the products and services, efficiency in production and expanding customer base, the Group will be able to weather the challenges ahead.

The Group did not issue any profit forecast or profit guarantee for the current quarter.
