The total revenue of the Group for the current quarter decreased by RM0.92 million or 2.4% as compared to the preceding year corresponding quarter. The decrease was mainly due to lower revenue from the Manufacturing segment but was offset partly by the higher revenue recorded by the Marketing and Distribution segment and Services segment. Cumulatively, the Group revenue decreased by RM12.40 million or 7.6% as compared to the preceding corresponding year. Both the Marketing and Distribution segment and Manufacturing segment recorded lower revenue while the Services segment recorded higher revenue.

The total PBT of the Group for the current quarter decreased by RM1.41 million or 29.5% in line with the lower revenue recorded.

Cumulatively the Group PBT decreased by RM3.44 million or 16.9% for the same reason.

#### (i) Marketing & Distribution segment

Current quarter revenue increased by RM2.08 million or 12.0% mainly due to higher revenue from power distribution equipment sold locally.

Cumulative revenue, however decreased by RM7.43 million or 8.7% mainly due to decline in the export of power distribution equipment.

Current quarter PBT increased by RM0.12 million or 6.9% due to higher contribution from power distribution equipment.

Cumulative PBT decreased by RM2.60 million or 22.1% in line with the decline in revenue.

## (ii) Manufacturing segment

Current quarter revenue decreased by RM5.41 million or 28.8% mainly due to delay in project execution for elevator and busduct systems.

Cumulatively, revenue decreased by RM5.13 million or 7.8% for the same reason.

Current quarter PBT decreased by RM1.75 million or 58.8% corresponding with the lower revenue from elevator and busduct systems.

Cumulatively, PBT decreased by RM1.94 million or 25.0% for the same reason.

Current quarter revenue increased by RM2.41 million or 115.6% due to the higher revenue from elevator repair sales and provision of electrical and security projects.

Cumulatively, revenue increased by RM0.16 million or 1.4% for the same reason.

Current quarter PBT increased by RM0.22 million or 541.5% corresponding with the higher revenue recorded. Cumulatively, PBT increased by RM1.10 million or 138.2% mainly due to the higher contribution from elevator maintenance contracts and repair sales.

The total revenue of the Group for the current quarter was lower by RM2.67 million or 6.7% as compared to the preceding quarter. The lower revenue recorded by Marketing and Distribution segment and Manufacturing segment was partly offset by the higher revenue from Services segment.
