EXPLANATORY NOTES TO THE INTERIM FINANCIAL REPORT

1. BASIS OF PREPARATION

The unaudited interim financial report is prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134 on "Interim Financial Reporting", paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad.

In accordance with MFRS 1 "First-time adoption of Malaysian Financial Reporting Standards", an opening MFRS statement of financial position has been presented at the date of transition to MFRS on 1 January 2011. There is no material differences between the opening MFRS statement of financial position and the statement of financial position presented under Financial Reporting Standards ("FRS") as at 31 December 2010.

The unaudited interim financial report should be read in conjunction with the Group's audited financial statements for the financial year ended 31 December 2011 and the accompanying explanatory notes attached to the unaudited condensed consolidated financial statements.

The significant accounting policies and methods adopted for the unaudited condensed consolidated financial statements are consistent with those adopted for the audited financial statements for the financial year ended 31 December 2011 except for the followings:

(a) Adoption of MFRS 1

In the current financial year, the Group adopts the new IFRS-compliant framework, MFRS by applying MFRS 1. MFRS 1 provides for certain optional exemptions and certain mandatory exceptions for first-time MFRS adopters which the Group has utilised as disclosed below:

Exemption for fair value as deemed cost - property, plant and equipment

Previously, the Group revalued a leasehold building of a subsidiary and the surplus on revaluation was credited to the revaluation reserve. In accordance with the transitional provisions issued by the Malaysian Accounting Standards Board (MASB) on adoption of FRS 116: Property, Plant and Equipment, the valuation of leasehold building was not updated and it continues to be stated at its existing carrying amount less depreciation as its deemed cost.

Upon transition to MFRS, the Group elected to apply the optional exemption to use the previous revaluation as deemed cost. Accordingly, the revaluation surplus of RM 390,414 (December 2011: RM 390,414) was transferred to retained earnings on the date of transition to MFRS on 1 January 2011.

(A) Review of performance for the current year to date results as compared with the previous year to date

The Group revenue in the current year increased by RM115.3 million (7.5%) compared with the previous year as a result of increase in activity in its FPSO, OSV and T&I segments despite marginal OFD segment revenue. Detailed comparison by segment is as follows:

- (a) The FPSO segment secured two new FPSO contracts towards the end of the second quarter 2011 Apache in Australia for the Balnaves field and ONGC in India for the D1 field. The ONGC contract was secured through a jointly controlled entity and accounted for as part of the share of results from jointly controlled entities.
- (b) The OSV segment revenue increased as a result of sustained improvement and recovery in the average fleet utilisation and new vessels acquired.
- (c) For the T&I segment, in addition to the guaranteed charter days from Petronas Carigali (Turkmenistan) Sdn Bhd for the Armada Installer, revenue increased due to the Lukoil project secured end of April 2012 and charter hire with Momentum Engineering.
- (d) The OFD segment revenue was lower due to the absence of new contracts.

The EBITDA margin increased as a result of higher margins from its new FPSOs, new OSV vessels and additional T&I contracts. The higher EBITDA led to a profit increase of RM22.7 million after accounting for the following:

- (a) higher depreciation of RM29.2 million mainly due to vessel additions in the FPSO, OSV and T&I segments;
- (b) higher finance costs of RM14.2 million mainly due to interest charged to the profit or loss upon completion of Armada TGT in August 2011; and
- (c) higher tax cost of RM10.0 million mainly due to deferred tax estimated on Apache FPSO project.

The Group posted a quarter on quarter increase in revenue of RM16.1 million (3.5%), driven by the following activities across all its established business segments:

- (a) FPSO revenue in the preceding quarter was higher as it included annual maintenance fees on TGT for completing one year of operation which sustained high uptime.
- (b) Higher OSV revenue in the current quarter as a result of higher utilisation of larger vessels in the fleet. The fleet utilisation rates are as shown below:

(c) Higher T&I revenue from deploying Armada Hawk on the D1 installation and higher contribution from its Lukoil project, recognised on a percentage of completion basis.

In line with higher revenue, the Group posted a higher EBITDA compared to the preceding quarter. This was increased by gains from foreign exchange and derivatives of RM3.7 million in the current quarter compared to a loss of RM5.7 million in the preceding quarter.

Profit increased in the current quarter by RM14.4 million after accounting for the following:

- (a) lower finance cost of RM2.0 million as a result of project debt repayments;
- (b) lower depreciation of RM20.9 million arising from a change in useful lives on selected vessels; and
- (c) higher tax cost of RM7.9 million mainly due to deferred tax estimates.

3. PROSPECTS FOR THE FINANCIAL YEAR ENDING 31 DECEMBER 2013

The long term outlook for the offshore oil and gas services sector remains positive with the long-term oil price expected to remain above US\$70/barrel and capital expenditure in the offshore O&G industry expected to remain robust as the search for oil in deep waters continues and the cost of E&P and offshore project development are expected to rise. However, concerns regarding the uncertainty over European sovereign debt, geopolitical risks and a continued slowdown in the global economy remain.

Notwithstanding the above, Bumi Armada anticipates robust activities across its major sectors of FPSO, OSV, T&I and OFD over the long term. Bumi Armada expects to consolidate its presence in Asia, Africa and Latin America and increase its penetration and market share across its business sectors in these regions.

4. QUALIFICATION OF PRECEDING AUDITED FINANCIAL STATEMENTS

There was no qualification to the preceding audited financial statements for the financial year ended 31 December 2011.

5. SEASONALITY OR CYCLICALITY OF OPERATIONS

The businesses of the Group were not materially affected by any seasonal or cyclical fluctuations during the financial year ended 31 December 2012.

6. ITEMS OF UNUSUAL NATURE, SIZE OR INCIDENCE

There were no items of an unusual nature, size or incidence affecting the assets, liabilities, equity, net income or cash flow of the Group during the current quarter.

7. CHANGES IN ESTIMATES

The useful lives of selected offshore support vessels (OSV) and the derrick lay barge were revised from 20 to 25 years and 25 to 30 years respectively to reflect the design and operating capabilities of these vessels. As a result of this revision, the depreciation charge of the Group has decreased by RM24.5 million for the current financial year.

8. ISSUANCE OR REPAYMENT OF DEBT AND EQUITY SECURITIES

Prior to the Acquisition, the Company owned 3,750,000 ordinary shares of RM1.00 each representing 50% of the issued capital of OMV. Following the Acquisition, the Company owns 100% of the issued share capital of OMV, resulting in OMV becoming a wholly-owned subsidiary of the Company.

19. STATUS OF CORPORATE PROPOSALS ANNOUNCED

On 20 November 2012, the Company's wholly-owned subsidiary, Bumi Armada Automation International Sdn Bhd had entered into a Conditional Sale and Purchase Agreement ("SPA") with Dyna-Mac Holdings Ltd ("Dyna-Mac") for the disposal of its entire 100% equity interest in Haven Automation Industries (S) Pte Ltd ("Haven") to Dyna-Mac for a cash consideration of SG\$5.0 million (the "Disposal"). Arising therefrom, Haven will cease to be an indirect wholly-owned subsidiary of the Company upon completion of the Disposal which is expected to occur within 3 months from the date of the SPA.

On 19 February 2013, Bumi Armada Automation International Sdn Bhd and Dyna-Mac had mutually agreed to extend the period for completion of the Disposal by an additional 3 months, to enable both parties to complete the pre-completion process. Accordingly, Haven will only cease to be a wholly-owned subsidiary of the Company upon completion of the Disposal which is expected to occur within 6 months from the date of the SPA.
