PART A: EXPLANATORY NOTES IN COMPLIANCE WITH MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134, INTERIM FINANCIAL REPORTING

A1. Accounting Policies and Basis of Preparation

The condensed financial report is unaudited and has been prepared in accordance with MFRS 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The condensed financial report should be read in conjunction with the audited annual financial report of the Company for the financial year ended 31 December 2013.

The explanatory notes attached to the condensed financial report provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Company, its subsidiaries and jointly-controlled entity since the financial year ended 31 December 2013.

The accounting policies and methods of computation adopted by the Company in this condensed financial report are consistent with those adopted in the most recent annual financial report for the year ended 31 December 2013, except for the adoption of new accounting standards.

A8. Changes in Composition of the Group

On 23 August 2013, the company entered into a share subscription agreement with the shareholders of SystemCorp Embeded Technology Pty Ltd ("SET") for a piecemeal acquisition of 1,060,665 ordinary shares of SET in total for a cash consideration of AUD1,060,665, equivalent to approximately RM3,162,903 and representing 51% of the total issued and paid-up share capital of SET by 15 June 2015.

As at 15 December 2014, the company has completed the acquisition of 880,700 ordinary shares representing 46.36% of the total issued and paid up share capital of SET for a consideration of AUD880,700.

B1. Review of performance of the Group

The Group recorded revenue of RM66.8 million and profit after taxation of RM7.4 million for the financial quarter under review. Revenue contributed by Projects and Products accounted for RM62.6 million or 93.8% and RM4.1 million or 6.2% respectively.

The group recorded a slightly lower gross profit margin of 25.5% for the financial period ended 31 December 2014, 0.8% lower than in the preceding year corresponding financial period ended 31 December 2013 of 26.3%. This is mainly due to composition of different stages of execution of projects.

B3. Variation of results against preceding year corresponding quarter

For the current financial quarter under review, we recorded revenue of RM66.8 million representing an increase of RM4.5 million or 7.2% as compared to RM62.3 million in the preceding year corresponding financial quarter. This is mainly due to increase in project awarded being implemented during this financial period.

During the financial quarter, our Project revenue had increased significantly from RM60.2 million in preceding year corresponding financial quarter to RM62.6 million, representing an increase of RM2.4 million or 4.0%. The increase in Project revenue was mainly due to billings for local projects for utilities and foreign projects.

During the financial quarter, our Group recorded Product revenue of RM4.1 million, an increase of RM2.1 million or 95.2% from RM2.0 million recorded in the preceding year corresponding financial quarter. The increase was mainly due to increase in Product sales to third party.

The Group recorded a profit after taxation of RM7.4 million, an increase of RM0.3 million or 4.2% as compared to preceding year corresponding financial quarter of RM7.1 million.

B4. Prospects

Buoyed by ample order book, PESTECH continues on along the path of growth with some emphasis on knowledge based business segment helm by its subsidiary, PESTECH Technology Sdn Bhd ("P-TECH"). The management is grooming this particular division of the Group with the aim to create a higher level of value added services offering, which may also help enhance its existing business segments of EPC.

P-TECH, indeed, did not disappoint. It had, on 15 January 2015, received a letter of acceptance from TNB Repair and Maintenance Sdn Bhd (a wholly-owned subsidiary of Tenaga Nasional Berhad) for the supply and provision of engineering assistant to install and commission the new governor system upgrading at SJ Tenom Pangi, Sabah. This Project is yet another milestone for P-TECH to localize know-how in the field of distributed control system for power plant automation. The successful completion of such a project would help build up a good reference for PESTECH to explore further opportunities in this business area with other regional power utilities.

Also equally if not more exciting, is the formation of PESTECH Power Sdn Bhd ("P-Power") on 26 January 2015. A 100% subsidiary of PESTECH, P-Power, with its principal business activity in owning and operating power transmission concessions both locally and overseas, led to the subsequent incorporation of Diamond Power Limited ("DPL"), a Cambodian registered special purpose vehicle, which is 60% owned by P-Power. DPL is currently vigorously pursuing power transmission concession opportunities in the Cambodia. Should a prospect is eventually procured, it will transform the Group's business structure, where a sustainable fixed income model could be included to elevate the base income of the Group, bringing stronger value proposition to its shareholders.

As such, the momentum of growth will be maintained as we move into a invigorating 2015.
