B1. Review of Performance of the Group

For the 3-month period ended 31 March 2018, the Group recorded a revenue of approximately RM27.79 million and loss before tax ("LBT") of approximately RM0.28 million. The revenue was mainly derived from land transport operations which accounted for approximately 93.23% of the Group's total revenue and 87.01 % of the Group's total LBT. The Group's revenue from land transport operations comprises cargo transportation services and container haulage services.

For the 3-month period ended 31 March 2018, cargo transportation services accounted for approximately 57.62% of the Group's total revenue and approximately 48.33% of the Group's total LBT whilst container haulage services accounted for approximately 35.61% of the Group's total revenue and approximately 38.68% of the Group's total LBT.

Warehousing and distribution operations accounted for approximately 6.40% of the Group's total revenue and 15.14% of the Group's total LBT for the 3-month period ended 31 March 2018. The period of warehousing varies between customers and the warehousing rental rate is charged based on a weekly or monthly basis. For the financial quarter under review, rental rate of the warehousing services has remained relatively constant.

Revenue derived from other services which comprise freight forwarding, customs brokerage, e-commerce services as well as manufacturing and fabrication of trailers accounted for approximately 0.36% of the Group's total revenue and marginally reduced the Group's total LBT by 2.46% for the 3-month period ended 31 March 2018.

The Group's revenue decreased by 0.05% from approximately RM27.80 million recorded in the immediate preceding financial quarter to approximately RM27.79 million in the current financial quarter. Profit after tax of the Group decreased by 72.76% from approximately RM3.24 million in the previous financial quarter to approximately RM0.88 million in the current financial quarter. The decreased in profit after tax as compared to the preceding quarter was mainly due to the provision of impairment of doubtful debts amounting to approximately to RM1.1million, bonus payout of approximately RM0.7 million and losses transactions in the e-commerce services of approximately RM 0.4 million recognised by the Group.
