
16. PROCEDURE FOR APPLICATION AND ACCEPTANCE FOR THE RESTRICTED ISSUE

FULL INSTRUCTIONS FOR THE ACCEPTANCE AND PAYMENT FOR THE RESTRICTED SHARES PROVISIONALLY ALLOTTED TO THE SHAREHOLDERS OF NCK AND THE PROCEDURES TO BE FOLLOWED, SHOULD THE SHAREHOLDERS OF NCK WISH TO DISPOSE OF ALL OR ANY OF THEIR ENTITLEMENT ARE SET OUT IN THE PAL. THE SHAREHOLDERS OF NCK ARE ADVISED TO READ THE PAL AND THE INSTRUCTIONS CONTAINED THEREIN CAREFULLY.

There is no minimum or maximum number of Restricted Shares that the Shareholders of NCK may need to apply for. There is also no multiple of additional Restricted Shares for which the Shareholders of NCK may need to apply for.

16.1 ACCEPTANCE IN FULL

If the Shareholders of NCK wish to **FULLY** accept the Restricted Shares provisionally allotted to them, they must complete the Form of Acceptance (Form A) of the PAL.

16.2 RENUNCIATION

The Restricted Issue is on a renounceable basis. The Shareholders of NCK may, by completing the PAL, apply for all or part of their entitlements. The Shareholders of NCK may split their entitlements under the Restricted Issue or renounce all or part thereof in favour of other parties. Should the Shareholders of NCK wish to completely renounce their rights to subscribe for the Restricted Shares provisionally allotted to, and to sell these entitlements, please complete the Form of Renunciation (Form R) only and forward the PAL in its **ENTIRETY** to the purchaser of their rights. In this event, please cancel the Form of Acceptance (Form A).

16.3 **EXCESS SHARES APPLICATION**

Payment under the respective Excess Restricted Issue Application Form should be in the same manner described above except that the Banker's Draft, Cashier's Order or Money Order should be made payable to "**APB EXCESS SHARES APPLICATION A/C**".

The Directors of the Company reserve the right to allot the Restricted Shares applied for under the Excess Shares Application Form in such manner as they deem fit. It is the intention of the Directors of APB to allot the APB Shares available for excess application (if any) in a fair and reasonable manner such that the incidence of odd lots will be minimised. In respect of unsuccessful or partially successful excess Restricted Issue application, the surplus application monies will be refunded in full without interest within **fifteen (15) market days** from the closing date for the excess Restricted Shares application by ordinary post at the address shown on the Excess Shares Application Form at your own risk.

16.4 **SPLITTING**

If the Shareholders of NCK wish to accept only part of the Restricted Shares provisionally allotted to them and dispose some or all of the Restricted Shares provisionally allotted to them to more than one person, please complete the Request for Splitting (Form S) only and forward the PAL in its ENTIRETY to the Company's Registrar, **Signet Share Registration Services Sdn Bhd, 11th Floor, Tower Block, Kompleks Antarabangsa, Jalan Sultan Ismail, 50250 Kuala Lumpur by 5:00 p.m. on 7 April 2004**, being the last TIME and DAY for splitting.

The split PAL, which will be sent to the Shareholders of NCK, will not be entitled for further splitting. The Shareholders of NCK will then be able to accept part of the Restricted Shares provisionally allotted to them and sell the other part(s) which they do not wish to accept or sell all to different persons. The same instructions with regards to acceptance and payment apply to the split PAL received as a result of the splitting of the original PAL.

The surrender of the PAL purporting to be signed by the Shareholders of NCK shall be conclusive evidence in favour of the Company of the title of the party depositing the PAL to deal with it and to receive the split PALs in exchange. 16.5 **CDS ACCOUNT**

Pursuant to Section 14(1) of the Securities Industry (Central Depository) Act, 1991, the MSEB has already prescribed the securities of APB to be deposited with the MCD. In consequence thereof, the Restricted Shares issued through this Prospectus are prescribed securities and any dealings in the Restricted Issue will be carried out in accordance with the aforesaid Act and the Rules of the MCD. Applicants are required to have securities accounts when making applications.

Where the PAL is issued to the Shareholders of NCK in respect of the relevant deposited securities which are standing to the credit of their CDS account, the acceptance of the Restricted Shares by the Shareholders of NCK shall mean that the Shareholders of NCK consent to receiving such Restricted Shares as deposited securities credited directly into their CDS account.

Where the PAL is issued to the Shareholders of NCK in respect of the relevant deposited securities which are standing to the credit of their CDS account, any person who intends to purchase such rights as a renounee shall have to state his/her CDS account number whereupon such Restricted Shares shall be credited directly as a deposited security into his/her CDS account.

An applicant of excess Restricted Shares must state his/her CDS account number and such Restricted Shares shall be credited directly into his/her CDS account if the applicant is allotted such shares.

16.6 **NOTICE OF ALLOTMENT**
