NOTES TO INTERIM FINANCIAL STATEMENTS FOR THE PERIOD ENDED 31 MARCH 2015

A1. Basis of Preparation

The condensed consolidated interim financial statements ("Report") have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. This Report also complies with IAS 34: Interim Financial Reporting issued by the International Accounting Standards Board ("IASB").

This condensed report should be read in conjunction with the audited financial statements for the financial year ended 30 September 2014. The explanatory notes attached to this Report provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 30 September 2014.

B1. Review of Performance of the Company and its Principal Subsidiaries

Current quarter (2Q15) against corresponding quarter of last year (2Q14)

For the quarter under review, the Group had recorded revenue of RM474.07 million which was higher by 3.09% or RM14.22 million than the revenue in last year corresponding quarter of RM459.85 million. The Group had recorded a profit before tax of RM12.81 million which was 0.46% higher than the RM12.75 million achieved in last year corresponding quarter.

The increase in the revenue was mainly due to longer period of festive season sales captured as Chinese New Year fell in later this year compare to last year. The profit before tax was higher than the previous corresponding quarter due to higher revenue recorded.

Current year to date (YTD 2015) against corresponding year to date (YTD 2014)

For the 6 months financial period as at 31 March 2015, the Group had achieved revenue of RM874.43 million which was 7.28% or RM21.55million lower than the revenue of RM895.99 million in the corresponding year to date and the profit before tax was dropped from RM22.74million to RM22.00million.

The drop in revenue was mainly due to the revenue dropped in the first quarter which effected from the flood in the east coast state of peninsular and the drop in the profit before tax was due to the drop in group's revenue.

Current Quarter (2Q15) against preceding quarter (1Q15)

The Group's revenue for the current quarter under review was RM474.07 million, an increase of 18.41% from the preceding quarter of RM400.37 million. Profit before tax for the current quarter under review was RM12.81 million, an increase of 39.50% as compare to RM9.18 million recorded in the preceding quarter.

The increase in both revenue and profit before tax was mainly due to higher sales recorded during Chinese New Year festive in current quarter under review.

B2. Commentary on Prospects

In view of the weakening consumers sentiment coupled with the recent implementation of Goods & Services Tax, the 2015 market conditions will remain challenging.

Despite the challenging environment faced in the retail industry, the Group will continue its efforts to realign its growth strategies and putting in place stringent cost control measures, pursue to increase market share in terms of quality, pricing and achieve a wide range of product varieties.

The Group is confident to deliver a satisfactory financial performance for the current financial year.

The Group did not issue any profit forecast nor profit guarantee during the current quarter under review.
