#### Review of Group's Results for the current quarter and Period-to-date ended 31 Dec 2022

The Group recorded a total revenue of RM19.045 million for the quarter ended 31 Dec 2022. The Group's loss before tax ("LBT") and loss after tax ("LAT") for the quarter were RM1.053 million and RM1.066 million respectively for the period.

The Group's revenue of RM69.526 million for the period to date 31 Dec 2022 represents an increase of approximately 6.75% as compared to the preceding corresponding period. The Group recorded LBT and LAT of RM6.237 million and RM6.250 million respectively for the period to date 31 Dec 2022 as compared to LBT and LAT of RM5.499 million respectively for the preceding year to date 31 Dec 2021.

The Group had recorded increases in revenue for the period to date compared to preceding year corresponding period. The group had not been able to generate a profit. The losses mainly contributed by higher depreciation RM 2.538 million as well as unrealised loss on foreign exchange RM 1.779 million from the period to date. The cost of copper clad laminates has been quite stable in the period and is forecasted to be kept manageable in the 4<sup>th</sup> quarter.

The Group recorded a decrease of approximately 28.96% in its revenue of RM19.045 million for the quarter ended 31 Dec 2022 against RM26.806 million for the immediate preceding quarter ended 30 Sep 2022. The reduction of revenue in the current quarter is lower orders from customers due to the global market condition. The Group recorded LBT and LAT of RM1.053 million and RM1.066 million respectively for the current quarter ended 31 Dec 2022, as compared to LBT and LAT of RM2.489 million respectively in the immediate preceding quarter ended 30 Sep 2022. A lower loss in current quarter was mainly due to lower of operating cost. There are a slight improvement on the Operating profit in the current quarter which have shown a positive outcome from the adjustment of the group selling prices to the customers and had been effective.

#### 3. Current year prospects

There is a slight slowing down on customers' demand generally starting from current quarter. Due to the global market condition, we expecting the slow demand will be continuous at least for the next 6 months. However, the Group is working closely with the customers to try to get hold of as much order as possible.

#### 4. Segment information

Segment information is presented in respect of the Group's geographical segments. Inter-segment pricing is determined based on a negotiated basis.
