#### Additional information required by the BMSB's Listing Requirements

#### 1 Review of performance

The revenue recorded in Q3 2009 decreased by 18% to RM26,310 million as compared to Q3 2008. Correspondingly, the profit before tax dropped by 93% to RM0.367 million. This was mainly due to the slow down in the sales of properties during the financial period under review as a consequence of the US credit crunch.

#### 2 Variance of results against preceding quarter

The Group's turnover for the current quarter decreased by 18% to RM26,310 million as compared with RM31.963 million recorded in the preceding quarter. Profit before tax dipped 82% to RM0.367 million.

#### 3 Current year / future prospects

The coming year is expected to be uncertain for the industry. Although governments in most countries have intervened to restore confidence in the financial institutions, the results remain to be seen. Currently, due to the uncertainty in the financial and job markets, consumers are holding back. However, low interest rates and the relative stability of property as an investment option bode well for the industry and continue to offer opportunities. As such, will monitor the situation before embarking on major launches.
