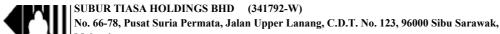

Prior to 1 August 2007, leasehold land was classified as property, plant and equipment and was stated at cost less accumulated depreciation and impairment losses.

The Group has applied the change in accounting policy in respect of leasehold land in accordance with the transitional provisions of FRS 117. At 1 August 2007, the unamortised carrying amount of leasehold land was classified as prepaid lease payments. The reclassification of leasehold land as prepaid lease payments have been accounted for retrospectively and certain comparative amounts as at 31 July 2007 have been restated as disclosed in Note 3.

(b) Revised FRS 112: Income Taxes

The adoption of Revised FRS 112 will allow the Group to recognise unutilised investment tax allowances and reinvestment allowances, to the extent it is probable that future taxable profit will be available against which unutilised investment tax allowances and reinvestment allowances can be utilised.

The Group has applied the change in accounting policy retrospectively in respect of the above in accordance with the transitional provisions of FRS 112 and adjusted the opening retained earnings. Note 13 Changes in the Composition of the Group

On 1 August 2007, the Company completed the acquisition of 2,500,000 ordinary shares of RM1 each, which represented 100% of the total issued and paid-up share capital of Borneo Lumber Industries Sdn. Bhd. ("BLI"), for a total cash consideration of RM8,000,000 upon the fulfillment of all the conditions precedent in the Sale and Purchase Agreement dated 3 May 2007 entered into with Mr Cheng Sung Tsung and a related party, Unique Wood Holdings Sdn. Bhd.

On 11 September 2007, the wholly-owned subsidiary of the Company, Infrapalm Sdn. Bhd. On 26 March 2008, the Company acquired two ordinary shares of RM1 each, which represented 100% of the total issued and paid-up share capital of JPH Logging Sdn. Bhd., for a total cash consideration of RM2.

On 28 April 2008, the Company entered into a Sale and Purchase Agreement of Shares for the acquisition of the entire ten thousand ordinary shares of RM1.00 each, which represented 100% of the total issued and paid-up share capital of Blessings Palm Sdn. Bhd., for a total cash consideration of RM3,706,500.00. The completion of the acquisition is pending for Foreign Investment Committee's approval.

Note 16 Review of Performance

In the current quarter under review, the Group achieved higher revenue of RM117.19 million, an increase of RM8.51 million or 8% as compared to RM108.68 million in the preceding year corresponding quarter. The Group recorded profit before tax of RM1.99 million and profit after tax of RM3.45 million as compared to RM15.77 million and RM11.91 million respectively in the preceding year corresponding quarter.

For the current financial year-to-date, the Group achieved higher revenue of RM422.26 million, a 6% increase when compared to revenue of RM399.60 million in the preceding year corresponding period. The Group recorded profit before tax of RM19.23 million and profit after tax of RM17.47 million as compared to profit before tax of RM71.23 million and profit after tax of RM53.33 million in the preceding year corresponding period.

The increase in revenue in the current quarter and financial year-to-date as compared to the corresponding period was mainly attributable to the higher plywood export sales revenue arising from higher plywood export sales volume, which is partially counteracted by the decrease in logs sales revenue. The decrease in profit before tax in the current financial year-to-date as compared to preceding year corresponding period, was mainly due to the lower profit derived from both the logging and plywood operations, which was in turn due to lower average selling prices.

Note 17 Variation in the Quarterly Results Compared to the Results of the Immediate Preceding Quarter

For the quarter under review, the Group recorded lower profit before tax amounting to RM1.99 million, a decrease of RM2.85 million as compared to RM4.84 million attained in the preceding quarter. The decrease in profit before tax was mainly due to lower profit from logging operations resulting from lower average selling prices.
