Notes to the condensed consolidated interim financial statements

V.S. Industry Berhad is a public limited liability company, incorporated and domiciled in Malaysia and is listed on the Main Market of the Bursa Malaysia Securities Berhad.

The condensed consolidated interim financial statements of the Group as at and for the six months period ended 31 January 2020 comprise the Company and its subsidiaries (together referred to as the Group) and the Group's interests in associates.

These condensed consolidated interim financial statements were approved by the Board of Directors on 26 March 2020.

1. Basis of preparation

(a) Statement of compliance

These condensed consolidated interim financial statements have been prepared in accordance with the applicable disclosure provisions of the Listing Requirements of the Bursa Malaysia Securities Berhad and MFRS 134, *Interim Financial Reporting* in Malaysia and with IAS 34, *Interim Financial Reporting*. They do not include all of the information required for full annual financial statements, and should be read in conjunction with the consolidated financial statements of the Group as at and for the year ended 31 July 2019.

2. Significant accounting policies

The accounting policies applied by the Group in these condensed consolidated interim financial statements are the same as those applied by the Group in its consolidated financial statements as at and for the year ended 31 July 2019, except for the adoption of MFRS 16, *Leases*.

MFRS 16 introduces a single, on-balance sheet lease accounting model for lessees. A lessee recognizes a right-of-use asset representing its right to use the underlying asset and a lease liability representing its obligations to make lease payments. Accordingly, the Group prepares its financial statements with adoption of MRFS 16 in its financial statements for the financial year ending 31 July 2020.

9. Material events subsequent to period end

Subsequent to the end of the reporting period, the Government has imposed Movement Control Order ("MCO") effective from 18 March 2020 to 1 April 2020 (which was later extended to 14 April 2020) in view of the Covid-19 pandemic, with the objectives to slow down the infection rate and bring the situation under control. The MCO measure would have certain adverse impact on the overall economy of the country, including the Group as well as other Electronics Manufacturing Services providers.

The magnitude of the impact of Covid-19 pandemic remains uncertain at this juncture, as it depends on the eventual duration of MCO and effectiveness of the preventive measures put in place by the authority.

The Group will continue to pay close attention to the development of the Covid-19 pandemic and the MCO, and evaluate the impact on the financial position and operating results of the Group going forward.

13. Review of performance

For the current quarter under review, the Group recorded a revenue of RM820.3 million, a decrease of RM158.7 million as compared to the previous year corresponding quarter, largely due to lower sales orders from key customers. Profit before tax, meanwhile, decreased 11.9% or RM5.9 million to RM43.5 million over the same period.

For the six months period ended 31 January 2020, the Group recorded a revenue of RM1,854.9 million, a decrease of RM197.0 million or 9.6% as compared to the corresponding period of the preceding year of RM2,051.9 million. Profit before tax stood at RM107.2 million, increased by 13.1% or RM12.5 million over the same period.

The reduced earnings for the current quarter was mainly attributable to lower sales orders from key customers. The improved earnings for the cumulative quarters was mainly attributable to much smaller losses from the operations in China following restructuring and streamlining of operations by adopting an asset-light and lower-cost model.

Malaysia segment

For the current quarter and cumulative quarters, Malaysia segment recorded a 19.4% and 9.6% decrease in revenue respectively due to lower sales orders from key customers. In tandem with the decrease in revenue, profit before tax dropped by 8.4% and 4.8% respectively over the same period.

Indonesia segment

Despite achieving higher revenue, Indonesia segment recorded loss before tax of RM1.5 million for the quarter under review as compared to profit before tax of RM0.3 million in the preceding year corresponding quarter mainly due to less favourable foreign exchange rate.

For the cumulative quarters, Indonesia segment continued to incur loss largely owing to under-utilization of production capacity.

China segment

For the current quarter and cumulative quarters, China segment recorded lower revenue as a result of lower sale orders completed. Losses narrowed significantly for the cumulative quarters due to lower operating expenses incurred following streamlining activities and adopting an asset-light model with lower gearing structure.

For the current quarter under review, the Group recorded a lower profit before tax of RM43.5 million as compared to RM63.7 million in the preceding quarter, in line with the decline in revenue as a result of lower sales orders from key customers.

15. Current year prospects

The operating environment has been challenging amidst the ongoing US-China trade tension and slowdown in global economy. The COVID-19 outbreak since January 2020, which has now turned pandemic, has further put much dampener on both local and global markets affecting trade activities and movement of people worldwide.

As a result of pandemic, supply chain experienced some delays in materials shipment as suppliers in China are now catching up on production since resuming operations in mid-February 2020. Meanwhile, on the demand side, outlook for the next few months appears uncertain at this juncture.

Given the extent and reach of COVID-19, the Group anticipate order flow from customers may slow down in the coming quarter(s), which in turn, would affect the financial performance in the second half of current financial year. Discussion with prospective customers have also been held up in view of the travel caution and restriction. In addition, the Movement Control Order ("MCO") implemented by the Government that is in place from 18 March 2020 to 1 April 2020 (subsequently extended to 14 April 2020) is also expected to have further impact on the operations of the Group.

However, the magnitude of the impact of Covid-19 pandemic and resulting MCO remains uncertain at this juncture, as it depends on the eventual duration of MCO and effectiveness of the preventive measures put in place by the authority.
