PART A -EXPLANATORY NOTES PURSUANT TO FRS134

A1 Basis of Preparation

The interim financial statements are unaudited and have been prepared in accordance with the requirements of Financial Reporting Standards ("FRS") No.134, "Interim Financial Reporting" and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2012. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2012.

A2. Changes in Accounting Policies

The new and revised FRSs, Amendments to FRS and IC Interpretations are mandatory for companies with financial periods beginning on or after 1 January 2013 which do not give rise to any significant effects on the financial statements of the Group.

Malaysian Financial Reporting Standards ("MFRS Framework")

On 19 November 2011, the Malaysian Accounting Standards Board (MASB) issued a new MASB approved accounting framework, the Malaysian Financial Reporting Standards (MFRS Framework).

The MFRS Framework is to be applied by all Entities Other Than Private Entities for annual periods beginning on or after 1 January 2012, with the exception of entities that are within the scope of MFRS 141 Agriculture (MFRS 141) and IC Interpretation 15 Agreements for Construction of Real Estate (IC 15), including its parent, significant investor and venturer (herein called 'Transitioning Entities').

Transitioning Entities will be allowed to defer adoption of the new MFRS Framework for an additional one year. Consequently, adoption of the MFRS Framework by Transitioning Entities will be mandatory for annual periods beginning on or after 1 January 2014. The Group falls within the scope definition of Transitioning Entities and accordingly, will be required to prepare financial statements using the MFRS Framework in its first MFRS financial statements for the year ending 31 December 2014.

In presenting its first MFRS financial statements, the Group will be required to restate the comparative financial statements to amounts reflecting the application of the MFRS Framework. The majority of the adjustments required on transition will be made, retrospectively, against opening retained earnings.

A2. Changes in Accounting Policies (con'd)

The Group has commenced transitioning its accounting policies and financial reporting from the current Financial Reporting Standards to the MFRS Framework by establishing a project team to plan and manage the adoption of the MFRS Framework.

The Group is in the process of assessing the financial effects of the differences between Financial Reporting Standards and accounting standards under the MFRS Framework. Accordingly, the consolidated financial statements and financial position as disclosed in these financial statements for the year ended 31 December 2012 could be different if prepared under the MFRS Framework.

The Group expects to fully comply with the requirements of the MFRS Framework for the financial year ending 31 December 2014.

A3. Auditors' Report on Preceding Annual Financial Statements

The auditors' report on the financial statements of the Company and its subsidiaries for the year ended 31 December 2012 were not subject to any qualification.

A4. Comments about Seasonal or Cyclical Factors

The business operations of the Group were not affected by any significant seasonal or cyclical factors.

There were no unusual items affecting the assets, liabilities, equity, net income or cash flow during the current quarter under review.

PART B – EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA SECURITIES

B1. Performance Review

The Group achieved a revenue of RM23.959 million for the first quarter ended 31 March 2013 as compared to RM24.065 million recorded in the comparative quarter, a decrease of RM0.106 million or 0.44%. The decrease in revenue was mainly due to Ready-Mix Concrete Division which registered a decrease of RM1.398 million whereas the Property Division registered an increase by RM1.051 million.

The Group registered a profit before tax of RM1.242 million for the first quarter ended 31 March 2013 as compared to a profit before tax of RM0.756 million for the comparative quarter ended 31 March 2012. The increase in profit was mainly due to profit on disposal of land use rights for RM0.889 million.

Industrial Gas Division

During the current quarter under review, the Industrial Gas Division recorded a revenue of RM7.766 million as compared to RM7.525 million recorded in the comparative quarter. The division recorded a profit before tax of RM1.007 million for the current quarter ended 31 March 2013 compared to a profit before tax of RM0.367 million for the comparative quarter. The higher profit was due to recognition of profit on disposal of land use rights of RM0.889 million.

In term of revenue, we managed to increase our market share marginally amidst the intense competition from all the major players. But, our profit margins were reduced.

• Ready-Mixed Division (RMC)

During the current quarter under review, the RMC Division recorded a revenue of RM10.820 million as compared to RM12.218 million recorded in the comparative quarter. The decrease in revenue was mainly due to slowdown in construction activities in Sabah for the first quarter.

The division recorded a profit before tax of RM0.189 million as compared to profit before tax of RM0.266 million for the comparative quarter.

• Property Division

During the current quarter under review, the Property Division recorded a revenue of RM5.373 million as compared to RM4.322 million recorded in the comparative quarter.

The division recorded a profit before tax of RM0.320 million against profit before tax of RM0.500 million in the comparative quarter.

Revenue for the current quarter under review was at RM23.959 million compared to RM23.128 million for the preceding quarter, increased by 3.59%. For the current quarter, the Group recorded a profit before tax of RM1.242 million as compared to a loss before tax of RM1.340 million for the preceding quarter ended 31 December 2012. The losses for the preceding quarter were attributable to recognition of impairment loss on trade receivables, inventories and deferred tax liabilities.

B3. Current Year Prospects

Malaysia's economy is anticipated to grow, albeit at a slower pace. While these sectors, namely industrial gas and ready-mixed concrete would expect greater pricing pressure and reduced profit margin due to intense competition. The Group continues to work on efficiency by enhancing the productivity and tighten costs control in order to remain competitive.

The Directors expect the Group's operating environment remains challenging and competitive in the coming quarter. Barring any unforeseen circumstances, the Group is optimistic and expects the performance of current year would be better than last year.
