Revenue

For the quarter under review, the Group's revenue increased approximately 4.1% to RM184.4 million as compared to the preceding quarter of RM177.1 million. The increase was mainly attributable to the followings:

- higher orders received in the quarter under review (see Note B5); and
- overall higher production output by all the factories of the Group in current quarter as compared to preceding quarter.

Gross profit

The Group has recorded higher gross profit from RM29.9 million in the preceding quarter to RM35.8 million in current quarter, representing an increase of 19.7%. The increase was in line with the increase in revenue and also mainly attributable to the followings:

- higher orders received of better margin products; and
- improved productivity.

Profit before taxation ("PBT")

The Group has recorded an increase in PBT from RM20.7 million in preceding quarter to RM26.0 million in current quarter. The increase in PBT was in line with the increase in revenue and gross profit margin.

Revenue

The Group recorded revenue of RM361.5 million for the six months financial period ended 31 December 2013 ("HY2014"), representing an increase of 37.9% as compared to the six months financial period ended 31 December 2012 ("HY2013") of RM262.1 million. The significant increase was mainly attributable to the followings:

- increase in monthly production capacity of a factory in Vietnam by approximately USD1.0 million:
- higher orders received in the period under review;
- strengthening of US Dollar against Ringgit Malaysia by 4.3%; and
- higher production output in the period under review as compared to corresponding period in FY2013.

Gross profit

Gross profit of the Group amounted to RM65.8 million in HY2014, representing an increase of 79.3% from RM36.7 million in HY2013. The significant increase was in line with the increase in revenue and also mainly attributable to the followings:

- higher orders received of better margin products;
- improved productivity; and
- upward revision of selling price of certain products.

Profit before taxation ("PBT")

PBT of the Group amounted to RM46.8 million in HY2014, representing an increase of 128.3% from RM20.5 million in HY2013. The substantial increase in PBT was in line with the substantial increase in gross profit due to better gross profit margin coupled with the decrease in finance costs.
