### B EXPLANATORY NOTES OF BURSA MALAYSIA LISTING REQUIREMENTS

#### **B1.** Review of performance

Group revenue for the quarter ended 31 December 2016 was RM 24.4 million as compared to RM 31.4 million in the corresponding period of the previous year. The decrease in revenue for the quarter was mainly attributed to downtime as a result of vessel docking and repairs and reduction in freight rates.

The Group made a current quarter loss of RM 7.9 million compared to a profit of RM 2.0 million in the same quarter last year. The losses were mainly due to unrealised foreign exchange losses of RM 4.8 million as well as a further RM 3.6 million in final exit costs from the container shipping division. Excluding these, the Group would have made a modest current quarter profit of RM 0.4 million.

#### **B2.** Comparison with preceding quarter's results

The Group revenue in the current quarter was RM 24.4 million which is RM 1.4 million improvement from the previous quarter of RM 23.0 million.

#### **B3.** Commentary on Prospects

Current economic market conditions are subdued but dry bulk shipping appears to have bottomed out. The Group expects the dry bulk shipping division's performance to remain steady as market recovery is expected to be slow.

The Group has completed its exit from the container shipping division as at 31 December 2016 except for some container assets which it still holds, but these have been written down to market value. Barring unforeseen circumstances, we do not foresee any extra ordinary losses from the sale of these assets.

Not applicable as the Group did not issue any profit forecast and /or profit guarantee for the quarter.

Domestic current income tax is calculated at the statutory tax rate of 24% (2016: 24%) of the estimated assessable profit for the year. Taxation for other jurisdictions is calculated at the rates prevailing in the respective jurisdictions. Certain subsidiaries of the Group enjoy tax exemptions from the relevant authorities on their business income for current and future periods. The computation of deferred tax as at the current period has reflected the effects of such exemptions.

## **B6.** Sales of unquoted investment and/or properties

There are no sales of unquoted investment and/or properties during the current quarter and financial year to date.

#### B7. Purchase or disposal of quoted securities

There was no purchase or disposal of quoted securities during the current quarter.

#### B8. Status of corporate proposals

On 18 July 2016, the Company announced a proposed capital restructuring exercise which comprises:

- The proposed reduction of issued and paid up share capital of the Company, involving the cancellation of RM 0.005 of the par value of each existing ordinary RM0.01 share;
- The proposed share consolidation of each ordinary share upon the completion of the proposed par value reduction on the basis of 20 ordinary shares of RM 0.005 each into one ordinary share of RM0.10 each:
- The proposed amendments to the terms of the deed polls of Warrants A and Warrants B as a result of the proposed par value reduction and proposed share consolidation;
- The proposed issuance of redeemable convertible notes with an aggregate principal amount of up to RM 200.0 million.

On 18 November 2016, the Company entered into a Supplemental Agreement with the Subscriber on the following:

- To revise the aggregate principal amount of the Notes from RM 200.0 million to RM 80.0 million;
- The minimum conversion price in relation to the conversion shares to be set at RM 0.05 upon the implementation of the Companies Act 2016.

On 14 December 2016, the Company received the letter of approval from Bursa Malaysia for this capital raising exercise. The Extraordinary General Meeting was subsequently held on 10 January 2017 where shareholders passed the resolution to reduce the par value of the Company to RM 0.005, to consolidate the ordinary shares of the Company 20:1 and allow the issuance of redeemable convertible notes with an aggregate principal of up to RM 80.0 million.

On 25 January 2017, the Company was granted the Court Order which reduced its par value to RM 0.005 per share. The share consolidation of 20:1 shares was allocated on 15 February 2017 consolidating every 20 ordinary shares of RM 0.005 each in the Company to one share of RM 0.10 each.

On 8 February 2017, the Company entered into a second Supplemental Agreement with the Subscriber to vary and amend certain terms in the Subscription Agreement pursuant to the implementation of the Companies Act 2016. On even date, the Company executed the Supplemental Deed Poll for Warrants A and Warrants B pursuant to the Deed Poll amendments.

All conditions precedent to the Subscription Agreement were completed by 17 February 2017 and the drawdown for sub-tranches 1 to 10 of Tranche 1 amounting to RM 2.5 million was received on 24 February 2017.
