1 Basis of Preparation

The interim financial report has been prepared in accordance with Financial Reporting Standard (FRS) 134₂₀₀₄, *Interim Financial Reporting*, issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2008. These explanatory notes attached to the interim financial statement provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2008.

2 Changes in Accounting Policies

The significant accounting policies adopted in the interim financial report are consistent with those of adopted in the most recent available annual audited financial statements for the year ended 31 December 2008 and in the previous quarter.

3 Declaration of audit qualification

The annual financial statements of the Group for the year ended 31 December 2008 were reported on without any qualification.

4 Seasonality or Cyclicality of interim operations

The Group's operations are not subject to seasonal or cyclical factors.

Nature and amount of items affecting assets, liabilities, equity, net income, or cash flows that are unusual because of their nature, size or incidence

There were no items affecting assets, liabilities, equity, net income, or cash flows that are unusual because of their nature, size and incidence.

Nature and amount of changes in estimates of amounts reported in prior interim periods of the current financial year, which give a material effect in the current interim period

There were no changes in estimates that have had material effect in the current quarter's results.

8 Dividends

The proposed final dividend of 1 sen per ordinary share of RM0.50 each less tax at 25% in respect of the year ended 31 December 2008 was approved by shareholders on 8 May 2009 and was paid to the shareholders on 29 May 2009.

Segmental reporting is not necessary as the Group is principally involved in manufacturing and sale of steel related products in Malaysia.

10 Valuation of property, plant and equipment

The valuation of land and buildings was brought forward without amendment from the previous annual report.

11 Material events subsequent to the end of the interim period

There were no material events subsequent to the end of the interim period.

12 Changes in composition of the Group

There was no change in the composition of the Group for the current quarter under review.

13 Changes in contingent liabilities or contingent assets

There are no contingent liabilities or assets for the current financial year to date.

14 Review of performance

The Group's total revenue for the quarter under review decreased by 42% to RM82 million as compared to RM142 million in the corresponding period of the preceding year. The reduction in revenue was mainly due to lower selling price and weak market demand on steel products. The Group reported a pre-tax profit of RM2.74 million as compared to RM17.05 million reported in the corresponding period of the previous year, mainly due to lower sales in volume and lower selling price in the current quarter against the steel price hike in the corresponding period of the preceding year.

Variation of results against preceding quarter

For the quarter under review, the Group recorded a profit before tax of RM2.74 million as compared to RM6.88 million pre-tax loss recorded in the previous quarter. The improved performance was resulted from higher revenue with more reflective selling prices and cheaper cost of input in the current quarter under review.

16 Current Year Prospects

- (a) The steel industry has shown sign of recovery with increasing demand and improved prices. Barring unforeseen circumstances, the Board of Directors is cautiously optimistic to post positive result in the second half of the year.
- (b) There were no announcements or disclosures published in a public document of any revenue or profit estimate, forecast, projection or internal targets as at the date of this announcement.
