A1 Accounting policies

The interim financial statements of the Group are unaudited and have been prepared in accordance with Malaysian Financial Reporting Standard ("MFRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2013. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the position and performance of Woodlandor Holdings ("Woodlandor" or the "Company") and its subsidiaries ("Group") since the year ended 31 December 2013.

Significant Accounting Policies

B1 Review of performance

The Group's revenue for the current financial quarter compared to the previous corresponding quarter decreased by RM0.67 million. The decrease was mainly attributable to the manufacturing segment.

Manufacturing segment

Revenue from manufacturing segment decreased from RM9.00 million to RM8.21 million over the corresponding quarter.

Trading segment

Revenue from trading segment increased from RM0.09 million to RM0.22 million over the corresponding quarter.

Overall, the Group registered a profit before tax of RM1.16 million for the current financial quarter as compared to a profit before tax of RM1.07 million in previous corresponding quarter.

B2 Comparison with the immediate preceding quarter's results

The Group posted a profit before tax of RM1.16 million for the current financial quarter as compared to a profit before tax of RM1.00 million in the immediate preceding quarter. This was mainly due to higher revenue recorded in the current financial quarter.

B3 Prospects

The Group's business segments are expected to operate in a challenging environment for the remaining period in 2014. However, the Group will strike to continue to improve its efficiency and focus on better margin product mix to improve the Group's profitability.
