Selected Explanatory Notes to the Interim Financial Statements for the first quarter ended 30 September 2021

A1 Accounting policies

The interim financial statements of the Group are unaudited and have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30 June 2021. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of Woodlandor Holdings Berhad ("Woodlandor" or the "Company") and its subsidiaries ("Group") since the year ended 30 June 2021.

B1 Review of performance

The Group's revenue for the current financial quarter compared to preceding year corresponding quarter (Q1 2020) decreased by RM1.544 million. The decrease was mainly due to Manufacturing segment.

Manufacturing segment

Revenue from manufacturing segment decreased from RM2.386 million to RM0.826 million over the corresponding quarter.

Trading segment

Trading revenue increased from RM0.218 million to RM0.234 million over the corresponding quarter.

Overall, the Group registered a loss before tax of RM1.435 million for the current financial quarter as compared to loss before tax of RM1.163 million in preceding year corresponding quarter (Q1 2020). This was mainly due to lower sales volume.

B2 Comparison with the immediate preceding quarter's result

The Group posted a loss before tax of RM1.435 million for the current financial quarter as compared to loss before tax of RM2.160 million in the immediate preceding quarter. This was mainly attributable to the higher impairment cost on inventory in the immediate preceding quarter.

B3 Prospect

The prolonged lockdown in Malaysia to curb the spread of COVID-19 remains a dampening factor to our national economic recovery.

The Group views that business operation will continue to be very challenging in view of the increasing prices of raw materials, inflationary cost pressure and moderate growth. The Board will continue to be prudent in operations and investments, focus on efforts to enhance operational and cost efficiencies.
