Selected Explanatory Notes to the Interim Financial Statements for the first quarter ended 31 December 2021

A1 Accounting policies

The interim financial statements of the Group are unaudited and have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30 June 2021. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of Woodlandor Holdings Berhad ("Woodlandor" or the "Company") and its subsidiaries ("Group") since the year ended 30 June 2021.

B1 Review of performance

The Group's revenue for the current financial quarter compared to preceding year corresponding quarter (Q2 2020) decreased by RM1.331 million. The decrease was mainly due to manufacturing segment.

Manufacturing segment

Revenue from manufacturing segment decreased from RM2.931 million to RM1.558 million over the corresponding quarter.

Trading segment

Trading revenue increased from RM0.365 million to RM0.407 million over the corresponding quarter.

Overall, the Group registered a loss before tax of RM0.632 million for the current financial quarter as compared to loss before tax of RM0.536 million in preceding year corresponding quarter (Q2 2020). This was mainly due to lower sales volume.

B2 Comparison with the immediate preceding quarter's result

The Group posted a loss before tax of RM 0.632 million for the current financial quarter as compared to loss before tax of RM1.435 million in the immediate preceding quarter. This was mainly attributable to the increase sale in manufacturing segment in the current financial quarter.

B3 Prospect

The economic outlook for 2022 continues to be challenging with the recent surge of new COVID-19 infections. Nevertheless, the Group continues with businesses operating under a "new normal" environment with COVID-19 pandemic.

The Group views that business operation will continue to be very challenging in view of the uncertainties in the local and global economies due to the effects of post Covid-19. The Board will continue to be prudent in operations and investments, focus on efforts to enhance operational and cost efficiencies.
