A1 Accounting policies

The interim financial statements of the Group are unaudited and have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30 June 2022. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of Woodlandor Holdings Berhad ("Woodlandor" or the "Company") and its subsidiaries ("Group") since the year ended 30 June 2022.

B1 Review of performance

The Group's revenue for the current financial quarter compared to preceding year corresponding quarter (Q2 2022) increased by RM0.094 million. The increase was mainly due to manufacturing segment.

Manufacturing segment

Revenue from manufacturing segment increased from RM1.558 million to RM1.696 million over the corresponding quarter.

Trading segment

Trading revenue decreased from RM0.407 million to RM0.363 million over the corresponding quarter.

Overall, the Group registered a loss before tax of RM0.899 million for the current financial quarter as compared to loss before tax of RM0.632 million in preceding year corresponding quarter (Q2 2022). This was mainly due to increase of operating cost in current financial quarter.

B2 Comparison with the immediate preceding quarter's result

The Group posted a loss before tax of RM 0.899 million for the current financial quarter as compared to loss before tax of RM 0.228 million in the immediate preceding quarter. This was mainly attributable to other income arose from the disposal of properties in the immediate preceding quarter.

B3 Prospect

Global economic uncertainties are expected to continue throughout 2023. The property industry remains challenging with escalating cost of building materials, supply chain disruptions, shortage of workers, foreign exchange fluctuation and uptrend in interest rate.

The Group will remain resilient and vigilant in addressing these challenges in its' business activities moving forward.
