A1 Accounting policies

B1 Review of performance

The Group's revenue for the current financial quarter compared to preceding year corresponding quarter (Q4 2023) increased by RM0.363 million. The increase was mainly due to manufacturing and trading segment.

Manufacturing segment

Revenue from manufacturing segment increased from RM1.980 million to RM2.303 million over the corresponding quarter.

Trading segment

Trading revenue increased from RM0.519 million to RM0.559 million over the corresponding quarter.

Overall, the Group registered a loss before tax of RM0.694 million for the current financial quarter as compared to loss before tax of RM0.840 million in preceding year corresponding quarter (Q4 2023). This was mainly due to the increase of sale in current quarter compare to preceding year corresponding quarter.

B2 Comparison with the immediate preceding quarter's result

The Group posted a loss before tax of RM 0.694 million for the current financial quarter as compared to loss before tax of RM 0.223 million in the immediate preceding quarter. This was mainly attributable to the decrease of sale in current financial quarter.

B3 Prospect

The Group view that the business operations are still challenging in terms of the uncertainties in the local and global economies and the inflationary pressure resulting in high production and operating costs.

The Board will remain cautious in operations and will continuously seek opportunities in domestic and overseas markets to strengthen our market presence.
