1 Basis of Preparation

The unaudited interim financial report has been prepared in accordance with the requirements of Chapter 9, Continuing Disclosure, Paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") and in compliance with Financial Reporting Standards ("FRSs") 134, Interim Financial Reporting issued by Malaysian Accounting Standards Board (MASB), and should be read in conjunction with the Group's annual audited financial statements for the year ended 31 December 2009.

14 Review of Performance

Comparison with Previous Year Corresponding Quarter's Results

Group revenue for the three months ended 31 March 2010 was RM114.094 million compared with RM87.999 million for the three months ended 31 March 2009, an increase of 29.65%. Group profit before taxation for the year ended 31 March 2010 was RM6.330 million, an increase of 166.30% over the RM2.377 million registered in the corresponding period in 2009. The increase in revenue was mainly due to the higher demand for the group's plastic packaging products subsequent to the strong economic recovery in some asian countries. The increase in profit before taxation was mainly due to the higher revenue achieved and better margins due to the higher demand.

The revenue for the quarter ended 31 March 2010 increased by RM4.636 million or 4.24% while profit before taxation increased by RM2.484 million or 64.59% as compared to the preceding quarter. The increase in revenue and margin was mainly due to the stronger demand for the group's plastic packaging products primarily in the asia pacific region.
