**PART A: EXPLANATORY NOTES PURSUANT TO FINANCIAL REPORTING STANDARDS 134 FOR THE INTERIM FINANCIAL STATEMENTS FOR THE 2ND QUARTER ENDED 30 SEPTEMBER 2014**

**A1. Basis of Preparation**

These unaudited condensed interim financial statements have been prepared in accordance with the applicable disclosure provisions of Paragraph 9.22 and Appendix 9B of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad (“Bursa Malaysia”) and in compliance with Financial Reporting Standard “FRS 134, Interim Financial Reporting”.

This quarterly financial report do not include all the information required for the full annual financial statements and should be read in conjunction with the annual audited financial statements of the Group for the year ended 31 March 2014.

**A2. Significant Accounting Policies**

The financial statements of the Group have been prepared in accordance with Financial Reporting Standards (FRS) and the Companies Act, 1965 in Malaysia.

Being a Transitioning Entity, the Company will adopt the MFRS and present its first set of MFRS financial statements when adoption of the MFRS is mandated by the MASB.

The Group recorded slightly lower revenue for the current quarter under review of RM1.851 million as compared to RM1.906 million for the corresponding quarter last year.

The manufacturing and replication of optical disc division recorded slightly lower revenue of RM1.851 million in the current quarter under review as compared to RM1.906 million for the corresponding quarter last year. There were no contributions to turnover from the property division in the current quarter under review pending new launches and construction of projects.

The Group recorded a higher loss before tax for the current quarter under review of RM0.89 million as compared to loss before tax of RM0.64 million for the corresponding quarter last year. This is mainly due to low sales volume of the optical disc division whilst still incurring factory overheads, and turnover contribution from property division has yet to come in.

The Group recorded lower revenue of RM1.851 million or 19% lower for the current quarter under review as compared to the preceding quarter's RM2.288 million.

The manufacturing and replication of optical discs division recorded lower revenue of RM1.851 million for the current quarter under review compared to RM2.136 in the preceding quarter. Turnover contribution from property division is pending new launches and construction of projects.

The Group recorded a higher loss before tax for the current quarter under review of RM0.89 million as compared to a loss before tax of RM0.819 million for the preceding quarter due to lower turnover.

**B3. Prospects for the current financial year**

Since the successful launch of g'Residence on 11 July 2014, GSB Properties Sdn. Bhd., a wholly-owned subsidiary of GSB Group, continues to register encouraging sales and construction is also under way. Barring unforeseen delays, work below ground level including foundation of the said g'Residence building is expected to be completed by end of the current financial year i.e. 31 March 2015.

Another wholly-owned subsidiary of GSB Group, Serta Usaha Sdn. Bhd., having received its approved Development Order, is now awaiting the other relevant approvals to build a gated & guarded community living development in Klang which consist townhouses, cluster homes and semi-detached homes. As such, this project is expected to be launched only in June 2015.

In addition, the Group is also awaiting relevant approvals for the development of commercial suites in Kelana Jaya near Paradigm Mall.

The Group is also continually looking to grow our property development segment via joint venture developments or acquisition of strategic land bank.

The Group has not provided any profit forecast or profit guarantee in any public document in respect of the current quarter ended 30 September 2014.
