As an integral part of the Group's listing exercise, the Company had on 26 January 2000 issued 25,598,305 new ordinary shares in respect of the acquisition of Lii Hen Furnitures Sdn Bhd, Rights Issue of 8,381,693 on 10 February 2000 and on 13 April 2000, issued 6,020,000 new ordinary shares of RM1.00 each in respect of the Public Issue undertaken by the Company. The entire paid-up capital of 40,000,000 shares are officially listed on the KLSE on 24 April 2000.

In tandem with the increase sales and interest saving arising from retirement of term loans and early settlement of certain hire purchase loans, profit after tax increase by 4.66% to RM2.065 million compared to RM1.973 in previous quarter.

# 18. REVIEW OF PERFORMANCE OF THE COMPANY AND ITS PRINCIPAL SUBSIDIARIES

The Group's increase sales and profit for the quarter under review were mainly attributed to higher sales of entertainment centers to USA.
