For the 3 months ended 30 June 2017, the Group recorded a lower revenue of RM89.485 million as compared to RM97.603 million in the same corresponding quarter ended 30 June 2016. The lower revenue mainly was due to lower selling price caused by lower LME price compared to the preceding quarter. However the Group registered loss before tax of RM0.698 million in the current quarter as compared to the loss before tax of RM1.653 million in the same corresponding period ended 30 June 2016 mainly due better exchange rates which contributed to foreign exchange gain.

For the 6 months ended 30 June 2017, the Group recorded a decrease in revenue of RM6.918 million to RM173.831 million, from RM180.749 million in the same corresponding period ended 30 June 2016. The decrease in revenue was mainly due to lower average selling price caused by the lower LME price. In addition, the lower revenue was also due to disposal of subsidiaries in China operation which cease the revenue contribution of 3.4% to the group. However the Group recorded a profit before tax of RM0.888 million in the current financial period ended 30 June 2017 as compared to a loss before tax of RM8.026 million in the same corresponding period ended 30 June 2016. The Group recorded gain due better exchange rates and ceasation of the non-profitable operations in China.

For the second quarter under review, the Group's revenue increased by 6.09% to RM 89.485 million as compared to RM 84.346 million in the preceding quarter. The increase of revenue was mainly due to the higher selling price caused by the LME price was picking up in the second quarter compared to the preceeding quarter. The group registered a loss before tax of RM0.698 million during the second quarter as compared to a profit before tax of RM1.586 million in the previous quarter. The Group suffered losses due the higher cost of production which could not be passed on to customers.

17. Commentary on Prospects

The copper rod and wire industry will continue to be a challenge due to the intense competition and the fluctuations of the copper prices at London Metal Exchange ("LME") and these fluctuations will continue to be of concern in the near future amidst the market volatility in the global economy. The fluctuations in copper prices remain the highest concern as it is the major determinant of profitability of the Group. Meanwhile, the management will constantly monitor the LME copper prices and exchange rates to control the material cost.

The Group believes in maintaining a close business relationship with all its customers, especially the major customers. It is still making initiatives to explore new overseas market potential. Meantime, the management will continue with its measures to control its operational costs by enhancing productivity with the same workforce and machineries.
