A. EXPLANATORY NOTES PURSUANT TO MFRS 134

1. Basis of Preparation

These condensed consolidated interim financial statements are unaudited and has been prepared in accordance with the requirements of MFRS 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board (MASB) and paragraph 9.22 and Appendix 9B of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia").

These interim consolidated financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2022 which was prepared in accordance with the MFRS. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2022.

2. Changes in Accounting Policies

The significant accounting policies adopted in the preparation of this condensed report are consistent with those of the audited financial statements for the financial year ended 31 December 2022 except for the mandatory adoption of the Malaysian Financial Reporting Standards ("MFRS"s), Amendments to MFRSs and IC Interpretations effective for the financial period beginning on or after 1 January 2023.

The initial adoption of these MFRSs, Amendments to MFRSs and IC interpretations do not have any material impact on the interim financial statements of the Group.

B. EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

16. Performance Review on Operating Segments

a) Current year to date vs previous year to date

The Group's revenue for the current period ended 30 September 2023 of RM192.674 million was marginally lower than the previous corresponding period of RM193.765 million, a decrease of 0.56% comparatively, due to lower revenue contributions from the Cable Support Systems division.

The Group recorded a higher profit before taxation of RM41.559 million for the period ended 30 September 2023 as compared to RM38.117 million in the previous corresponding period, mainly contributed by higher profit margins achieved on goods sold from the Cable Support Systems division during the period under review.

Performance of the respective operating business segments for the current period ended 30 September 2023 as compared to previous corresponding period are as follows:-

Cable Support Systems

For the current period ended 30 September 2023, this business segment registered a marginally lower revenue of RM169.048 million as compared to RM172.798 million in the previous corresponding period, a decrease of 2.17% comparatively.

This segment recorded a higher profit before taxation of RM41.730 million as compared to RM38.589 million in the previous corresponding period, mainly attributable to higher profit margins achieved on goods sold and higher interest income during the period under review.

16. Performance Review on Operating Segments (Continued)

a) Current year to date vs previous year to date (Continued)

Electrical Lighting and Fittings

For the current period ended 30 September 2023, this business segment registered a higher revenue of RM23.627 million as compared to RM20.968 million in the previous corresponding period, an increase of 12.68% comparatively.

This segment recorded a higher profit before taxation of RM0.654 million as compared to RM0.205 million in the previous corresponding period, mainly attributable to higher revenue achieved during the period under review.

b) Current quarter vs previous year corresponding quarter

The Group's revenue for the current quarter ended 30 September 2023 of RM69.491 million was higher than the previous corresponding period of RM62.285 million, mainly due to higher revenue contributions from both Cable Support Systems and Electrical Lighting and Fittings divisions.

The Group recorded a higher profit before taxation of RM14.943 million for the quarter ended 30 September 2023 as compared to RM12.813 million in the previous corresponding quarter, mainly attributable to higher profit margins achieved on goods sold from the Cable Support Systems division during the quarter under review.

Performance of the respective operating business segments for the current quarter ended 30 September 2023 as compared to previous corresponding quarter are as follows:-

Cable Support Systems

For the current quarter ended 30 September 2023, this business segment registered a higher revenue of RM60.435 million as compared to RM55.706 million in the previous corresponding quarter, an increase of 8.49% comparatively.

This segment recorded a higher profit before taxation of RM14.802 million as compared to RM13.123 million in the previous corresponding quarter, mainly attributable to higher profit margins achieved on goods sold and higher revenue generated during the quarter under review.

b) Current quarter vs previous year corresponding quarter (Continued)

Electrical Lighting and Fittings

For the current quarter ended 30 September 2023, this business segment registered a higher revenue of RM9.056 million as compared to RM6.579 million in the previous corresponding quarter, an increase of 37.65% comparatively.

This segment recorded a higher profit before taxation of RM0.395 million as compared to RM0.111 million in the previous corresponding quarter, mainly attributable to higher revenue generated during the quarter under review.

17. Material Changes in Profit Before Taxation for the Current Quarter as Compared to the Preceding Quarter

For the current quarter under review, the Group had achieved a lower profit before taxation of RM14.943 million as compared to RM20.633 million in the immediate preceding quarter. The decrease in profit before taxation is mainly due to lower profit margins achieved on goods sold during the current quarter under review as compared to the immediate preceding quarter.

18. Commentary on Prospects

Malaysia's construction industry is forecast to grow further, in line with the government's focus on completing infrastructure, industrial and energy projects. Under these positive circumstances, the Group believes that the domestic and international markets for Cable Support Systems and Electrical Lighting and Fittings products are expected to improve. Nevertheless, the Group will continue to exercise caution in all its business dealings as future local and global markets condition remain uncertain.

The Group takes cognizance of new measures to enhance its operations and improve its cash flow position. Meanwhile, the Group also optimises its revenue stream by expanding its customer base as downstream players start to replenish their inventories.

19. Profit Forecast or Profit Guarantee

The explanatory notes for the variance of actual profit after tax and minority interest and forecast profit after tax and minority interest and for the shortfall in profit guarantee are not applicable.
