## 19. PROCEDURE FOR APPLICATION AND ACCEPTANCE

---

### 19.1 OPENING AND CLOSING OF APPLICATION LISTS

Application will open at 10.00 a.m. on 23 June 2003 and will remain open until 8.00 p.m. on 7 July 2003 or for such further period or periods as the Board of Directors of CHB and the Underwriters in their absolute discretion may mutually decide. Correspondingly, the application lists for the Public Issue Shares will open at 10.00 a.m. and will remain open until 8.00 p.m. at the closing date of applications. Late application will not be accepted.

### 19.2 METHODS OF APPLICATION

Applications for the Public Issue Shares, Offer Shares, and Special Issue Shares may be made in the following manner:

- (i) Application Forms; or
- (ii) ESA

### 19.3 APPLICATION USING APPLICATION FORMS

The following relevant Application Forms issued with their Notes and Instructions are enclosed with this Prospectus:

- (i) **Pink** Application Forms for applications by eligible employees, Directors and business associates (comprising of stockists, selected suppliers and leading distributors) of the CHB Group;
- (ii) **White** Application Forms for application by Bumiputera investors approved by the MITI; and
- (iii) **White** Application Forms for application by Malaysian citizens, companies, societies, co-operatives and institutions, of which at least 30% is to be set aside strictly for Bumiputera individuals, companies, societies, co-operatives and institutions.

White Application Forms together with copies of this Prospectus may be obtained, subject to availability, from CIMB, member companies of the KLSE, members of the Association of Banks in Malaysia, members of the Association of Merchant Banks in Malaysia and MIH.

### 19.4 PROCEDURES FOR APPLICATION

- (i) **Applications by the eligible employees, Directors and business associates (comprising of stockists, selected suppliers and leading distributors) of the CHB Group**

Applications for the Public Issue Shares of RM0.65 per Share reserved for the eligible employees, Directors and business associates of CHB Group must be made on the **Pink** Application Forms provided and not on any other Application Forms nor by way of ESA.

- (ii) **Applications by Bumiputera investors as approved by the MITI**

Applications for the Special Issue Shares and Offer Shares of RM0.65 per Share reserved for Bumiputera investors as approved by the MITI must be made on the **White** Application Forms provided and not by way of ESA.

- (iii) **Applications by the Malaysian public**

Applications for the Public Issue Shares of RM0.65 per Share made available for application by Malaysian citizens, companies, societies, co-operatives and institutions must be made on the **White** Application Forms provided or by way of ESA.

**Directors and employees of MIH and their immediate family are strictly prohibited from applying for the Public Issue Shares.**

Only one Application Form from each applicant will be considered and applications must be for 100 ordinary shares or multiples thereof. Multiple applications will not be accepted. The amount payable in full on application is RM0.65 per Share. Persons submitting applications by way of Application Forms may not submit applications by way of ESA and vice versa. A corporation or institution cannot apply for shares by way of ESA.

Application for the Public Issue Shares must be made on the Application Forms issued together with this Prospectus and must be completed in accordance with the Notes and Instructions printed on the reverse side of the Application Forms. In accordance with Section 41(2) of the Securities Commission Act, 1993, the Application Forms together with the Notes and Instructions printed therein are accompanied by this Prospectus. Applications which do not **STRICTLY** conform to the terms of this Prospectus or the Application Forms or Notes and Instructions printed therein or which are illegible will not be accepted.

IN THE CASE OF A CORPORATE/INSTITUTIONAL APPLICANT, THE NAME OF THE APPLICANT MUST BE EXACTLY THE SAME AS THAT IN THE APPLICANT’S CERTIFICATE OF INCORPORATION AND THE ADDRESS MUST BE EXACTLY THE SAME AS THE REGISTERED ADDRESS.

AN APPLICANT SHOULD STATE HIS CDS ACCOUNT NUMBER IN THE SPACE PROVIDED IN THE APPLICATION FORM IF HE PRESENTLY HAS SUCH AN ACCOUNT AND HE SHALL BE DEEMED TO HAVE AUTHORISED MCD TO DISCLOSE INFORMATION PERTAINING TO THE CDS ACCOUNT TO THE ISSUING HOUSE/COMPANY. WHERE AN APPLICANT DOES NOT PRESENTLY HAVE A CDS ACCOUNT HE SHOULD STATE IN HIS APPLICATION FORM HIS PREFERRED ADA CODE.

APPLICATIONS ACCOMPANIED BY MODE OF PAYMENT OTHER THAN THOSE STATED ABOVE OR WITH EXCESS OR INSUFFICIENT REMITTANCES OR INAPPROPRIATE BANKER'S DRAFT/CASHIER'S ORDER WILL NOT BE ACCEPTED. DETAILS OF REMITTANCES MUST BE COMPLETED IN THE APPROPRIATE BOXES PROVIDED ON THE APPLICATION FORMS.

The Directors of the Company reserve the right to require any successful applicant to appear in person at the registered office of MIH within fourteen (14) days of the date of the notice issued to him to ascertain the regularity or propriety of the application. The Directors of the Company shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant for the purpose of complying with these provisions.

The Directors of the Company reserve the right to reject applications which do not conform to these instructions or which are illegible or which are accompanied by remittances improperly drawn.

The Directors of the Company reserve the right not to accept any application or accept any application in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating the Shares to a reasonable number of applicants with a view to establishing an adequate market for the shares.

Where an application is not accepted, the full amount of the application monies, without interest, will be returned and dispatched to the applicant within twenty-one (21) days from the date of the final ballot of the Applications Lists by registered post at the address shown on the Application Form at the applicant's own risk.

MIH reserves the right to bank in all application monies from unsuccessful Bumiputera applicants and partially-successful applicants, which would subsequently be refunded without interest by registered post.

No acknowledgement of the receipt of Application Forms or application monies will be made by the Company.

**19.6 APPLICATIONS USING ESA**

- (i) **Steps for ESA through a PFI's ATM**
  - (a) Applicant must have an account with a PFI and an ATM card issued by that PFI to access the account.
  - (b) Applicant must have a CDS account.

(c) Applicant is to apply for the Public Issue Shares via the ATM of the PFI by choosing the ESA option. Mandatory statements required in the application are set out in Section 19.6 (ii) under the Terms and Conditions for ESAs. Applicant is to enter at least the following information through the ATM where the instructions on the ATM screen at which he enters his ESA requires him to do so:

- Personal Identification Number (PIN);
- **MIH Share Issue Account Number 252;**
- CDS Account Number;
- Number of Shares applied for and/or the Ringgit Malaysia amount to be debited from the account; and
- Confirmation of several mandatory statements.

**(ii) Terms and Conditions for ESA**

The procedures for ESAs at ATMs of the PFI are set out on the ATM screens of the relevant PFI ("Steps"). For illustration purposes, the procedures for ESA at ATMs are set out in "Steps for ESA through a PFI's ATM" in Section 19.6 (i) of this Prospectus. The Steps set out the actions that the applicant must take at the ATM to complete an ESA. Please read carefully the terms of this Prospectus, the Steps and the terms and conditions for ESAs set out below before making an ESA. Any reference to "applicant" in the terms and conditions for ESAs and the Steps shall mean the applicant who applies for shares through an ATM of any of the PFI.

In the case of ESA, only an applicant who is an individual with a CDS Account is eligible to utilise the facility.

The applicant must have an existing bank account with, and be an ATM cardholder of, one of the PFIs before he can make an ESA at an ATM of that PFI. An ATM card issued by one of the PFIs cannot be used to apply for shares at an ATM belonging to other PFIs. Upon the completion of his ESA transaction, the applicant will receive a computer-generated transaction slip ("Transaction Record"), confirming the details of his ESA. The Transaction Record is only a record of the completed transaction at the ATM and not a record of the receipt of the ESA or any data relating to such an ESA by the Company or MIH. The Transaction Record is for retention by the applicant and should not be submitted with any Application Form.

Upon the closing of the Offer for the application for the Public Issue Shares on 7 July 2003 at 8.00 p.m. ("Closing Date and Time"), the PFI shall submit a magnetic tape containing its respective customers' applications for the Public Issue Shares to MIH as soon as practicable but not later than 12.00 p.m. of the 2<sup>nd</sup> business day after the Closing Date and Time.

An applicant will be allowed to make an ESA for shares via an ATM that accepts the ATM cards of the PFI with which he has an account and its branches, subject to the applicant making only one application.

An applicant who has a bank account with a PFI and has been issued an ATM card will be allowed to apply for shares via an ATM of that PFI which is situated in another country or place outside of Malaysia, subject to the applicant making only one (1) application. A fee of RM2.50 per application will be charged.

AN APPLICANT MUST ENSURE THAT HE USES HIS OWN CDS ACCOUNT NUMBER WHEN MAKING AN ESA. AN APPLICANT OPERATING A JOINT ACCOUNT WITH ANY PFI MUST ENSURE THAT HE ENTERS HIS OWN CDS ACCOUNT NUMBER WHEN USING AN ATM CARD ISSUED TO HIM IN HIS OWN NAME. HIS APPLICATION WILL BE REJECTED IF HE FAILS TO COMPLY WITH THE FOREGOING.

The ESA shall be made on, and subject to, the terms and conditions contained herein as well as the terms and conditions appearing below:

- (a) The ESA shall be made in connection with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of the Company.
- (b) The applicant is required to confirm the following statement (by depressing pre-designated keys (or buttons) on the ATM keyboard) and undertake that the following information given is true and correct:
  - I have attained 18 years of age as at the closing date of the share application.
  - I am a Malaysian citizen residing in Malaysia.
  - I have read the relevant Prospectus and understood and agreed with the terms and conditions of this application.
  - This is the only application that I am submitting.
  - I hereby give consent to the PFI and MCD to disclose information pertaining to myself and my account with the PFI and MCD to MIH and other relevant authorities.

The application will not be successfully completed and cannot be recorded as a completed transaction at the ATM unless the applicant completes all the steps required by the PFI. By doing so, the applicant shall be treated as signifying his confirmation of each of the above statements as well as giving consent in accordance with the relevant laws of Malaysia including Section 97 of the Banking and Financial Institutions Act 1989 and Section 45 of the Securities Industry (Central Depositories) Act 1991 to the disclosure by the relevant PFI or MCD, as the case may be, of any of the applicant's particulars to MIH, or any relevant regulatory bodies.

- (c) THE APPLICANT CONFIRMS THAT HE IS NOT APPLYING FOR SHARES AS NOMINEE OF ANY OTHER PERSONS AND THAT ANY ESA THAT HE MAKES IS MADE BY HIM AS BENEFICIAL OWNER. THE APPLICANT SHALL ONLY MAKE ONE ESA AND SHALL NOT MAKE ANY OTHER APPLICATION FOR THE PUBLIC ISSUE SHARES, WHETHER AT THE ATMS OF ANY PFI OR ON THE PRESCRIBED APPLICATION FORMS.
- (d) The applicant must have sufficient funds in his account with the relevant PFI at the time he makes his ESA, failing which his ESA will not be completed. Any ESA which does not strictly conform to the instructions set out on the screens of the ATM through which the ESA is being made will be rejected.

- (e) The applicant agrees and undertakes to subscribe for or purchase and to accept the number of shares applied for as stated on the Transaction Record or any lesser number of shares that may be allotted or allocated to him in respect of his ESA. In the event that the Company decides to allot or allocate any lesser number of such shares or not to allot or allocate any shares to the applicants, the applicant agrees to accept any such decision as final. If the applicant's ESA is successful, his confirmation (by his action of pressing the designated key on the ATM) of the number of shares applied for shall signify, and shall be treated as, his acceptance of the number of shares that may be allotted or allocated to him and to be bound by the Memorandum and Articles of the Company.
- (f) The Company reserves the right to reject any ESA or accept any ESA in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating the shares to a reasonable number of applicants with a view to establishing an adequate market for the shares.
- (g) Where an ESA is not successful or successful in part only, the relevant PFI will be informed of the non-successful or partially successful applications. Where the ESA is not successful, the relevant PFI will credit the full amount of the application monies without interest into the applicant's account with that PFI within two (2) market days after the receipt of confirmation from MIH. MIH shall inform the PFI of the non- successful or partially successful applications within two (2) market days after the balloting date. The applicants may check their accounts on the fifth market day from the balloting day.

Where an ESA is accepted in part only, the relevant PFI will credit the balance of the application monies without interest into the applicant's account with the PFI within two (2) market days after the receipt of confirmation from MIH. A number of applications will, however, be held in reserve to replace any successfully balloted applications which are subsequently rejected. For such applications which are subsequently rejected, the application monies without interest will be refunded to applicants by MIH by way of cheques issued by MIH. The cheques will be issued to the applicants not later than twenty-one (21) days from the day of the final ballot of the application list.

- (h) The applicant requests and authorises the Company:
  - (i) to credit the shares allotted or allocated to the applicant into the CDS account of the applicant; and
  - (ii) to issue share certificate(s) representing such shares allotted or allocated in the name of MCD Nominees Sdn Bhd, and send the same to MCD.
- (i) The applicant, acknowledging that his ESA is subject to the risks of electrical, electronic, technical and computer-related faults and breakdowns, fires and other events beyond the control of the Company, MIH or the PFI, irrevocably agrees that if:
  - (i) the Company or MIH does not receive the applicant's ESA; or
  - (ii) data relating to the applicant's ESA is wholly or partially lost, corrupted or not otherwise accessible, or not transmitted or communicated to the Company or MIH,

the applicant shall be deemed not to have made an ESA and the applicant shall not claim whatsoever against the Company, MIH or the PFIs for the shares applied for or for any compensation, loss or damage.

- (j) All particulars of the applicant in the records of the relevant PFI at the time he makes his ESA shall be deemed to be true and correct and the Company, MIH and the relevant PFI shall be entitled to rely on the accuracy thereof.
- (k) The applicant shall ensure that his personal particulars as recorded by both MCD and relevant PFI are correct and identical. Otherwise, his ESA is liable to be rejected. The applicant must inform MCD promptly of any change in address failing which the notification letter of successful allotment or allocation will be sent to his registered address last maintained with MCD.
- (l) By making and completing an ESA, the applicant agrees that:
  - (i) in consideration of the Company agreeing to allow and accept the making of any application for shares via the ESA facility established by the PFIs at their respective ATMs, his ESA is irrevocable;
  - (ii) the Company, the PFIs, MCD and MIH shall not be liable for any delays, failures or inaccuracies in the processing of data relating to his ESA to the Company due to a breakdown or failure of transmission or communication facilities or to any cause beyond their control;
  - (iii) notwithstanding the receipt of any payment by or on behalf of the Company, the acceptance of the offer made by the applicant to subscribe for and purchase the shares for which the applicant's ESA has been successfully completed shall be constituted by the issue of notices of successful allotment for prescribed securities, in respect of the said shares;
  - (iv) the applicant irrevocably authorizes MCD to complete and sign on his behalf as transferee or renounee any instrument of transfer and/or other documents required for the issue or transfer of the shares allotted or allocated to the applicant; and
  - (v) the Company agrees that, in relation to any legal action or proceedings arising out of or in connection with the contract between the parties and/or the ESA Scheme and/or any terms herein, all rights, obligations and liabilities shall be construed and determined in accordance with the laws of Malaysia and with all directives, rules, regulations and notices from regulatory bodies and that the Company irrevocably submits to the jurisdiction of the Courts of Malaysia.
- (m) The Directors of the Company reserve the right to require any successful applicant to appear in person at the registered office of MIH within fourteen (14) days of the date of the notice issued to him to ascertain the regularity or propriety of the application. **19.7 APPLICATIONS AND ACCEPTANCES**

The Directors of CHB reserve the right not to accept any application which does not strictly comply with the instructions or to accept any application in part only without assigning any reason therefor.

The submission of an Application Form does not necessarily mean that the application will be successful.

**ALL APPLICATIONS MUST BE FOR 100 ORDINARY SHARES OR MULTIPLES THEREOF.**

In the event of an over-subscription for the Public Issue Shares, acceptance of applications shall be subject to ballot to be conducted in the manner approved by the Directors of CHB. The basis of allocation to be devised shall be in such manner as to spread the shareholding base in CHB over a reasonable number of applications with a view to establishing an adequate market in CHB Shares. Pursuant to the SC's Policies and Guidelines on Issue/Offer of Securities, the Company is required to have at least 25% of the issued and paid-up capital in the hands of public shareholders and a minimum number of 500 public shareholders (excluding employees) holding not less than 100 shares each upon completion of the Public Issue and at the point of listing.

However, in the event that the above requirement is not met pursuant to this Public Issue, the Company may not be allowed to proceed with its listing plan, in which event all application monies will be returned without interest. Applicants will be selected in a manner to be determined by the Directors of the Company.

Any shares not subscribed by the eligible employees, Directors and business associates of the CHB Group will be made available for application by the Malaysian public. In the event of an under-subscription by the Malaysian public, all the ordinary shares not applied for will be made available for subscription proportionately by the Managing Underwriter and the Underwriters in the proportions specified in the Agreement in relation to the underwriting.

WHERE AN APPLICATION IS NOT ACCEPTED OR ACCEPTED IN PART ONLY, THE FULL AMOUNT OR THE BALANCE OF THE APPLICATION MONIES, AS THE CASE MAY BE, WILL BE REFUNDED WITHOUT INTEREST AND SHALL BE DESPATCHED BY ORDINARY POST OR REGISTERED POST RESPECTIVELY TO THE APPLICANT WITHIN TWENTY-ONE (21) DAYS FROM THE DATE OF THE FINAL BALLOT OF THE APPLICATION LISTS AT THE ADDRESS SHOWN ON THE APPLICATION FORM AT THE APPLICANT'S OWN RISK.

NO APPLICATION SHALL BE DEEMED TO HAVE BEEN ACCEPTED BY REASON OF THE REMITTANCES HAVING BEEN PRESENTED FOR PAYMENT.

THE ISSUING HOUSE RESERVES THE RIGHT TO BANK IN ALL APPLICATION MONIES FROM UNSUCCESSFUL BUMIPUTRA APPLICANTS AND FROM PARTIALLY SUCCESSFUL APPLICANTS WHICH WILL BE SUBSEQUENTLY REFUNDED WITHOUT INTEREST AND DESPATCHED BY REGISTERED POST TO THE APPLICANT WITHIN TWENTY-ONE (21) DAYS FROM THE DATE OF THE FINAL BALLOT OF THE APPLICATION LISTS AT THE ADDRESS SHOWN ON THE APPLICATION FORM AT THE APPLICANT'S OWN RISK.

**19.8 CDS ACCOUNTS**

Pursuant to Section 29 of the Securities Industry (Central Depositories) Act, 1991, all dealings in ordinary shares of CHB shares will be by book entries through CDS Accounts. No share certificates will be issued to successful applicants.

In the case of an application by way of an Application Form, an applicant should state his CDS account number in the space provided in the Application Form if he presently has such accounts. If the applicant does not presently have such an account, he should state his preferred ADA Code in the space provided. If a successful applicant fails to state either his CDS account number or the preferred ADA Code in his Application Form, the Company may, in the exercise of its absolute discretion, instruct MIH to insert a preferred ADA Code in the Application Form and further instruct MCD to open a CDS account on the applicant's behalf at the specified ADA and credit the shares allocated to the applicant into the applicant's CDS account.

Where an applicant already has a CDS account, his completion of the Application Form includes his authority for MCD to disclose information pertaining to the CDS account to the Issuing House or the Company.

In the case of an application by way of ESA, only an applicant who has a CDS account can make an ESA and the applicant shall furnish his CDS account to the PFI by way of keying in his CDS account number if the instruction on the ATM screen at which he enters his ESA requires him to do so.

Failure to comply with these specific instructions as the ESA requires or inaccuracy in the CDS Account number or the preferred ADA Code may result in the application being rejected. For ESAs, the notice of allocation will be despatched to the successful or partially successful applicant at his/her address last maintained with the MCD at the applicant's own risk within thirty (30) days after the final ballot of the application list. This is the only acknowledgement of acceptance of the application.

**19.10 FORMALISING CDS ACCOUNTS**

Successful applicants whose CDS Accounts have been opened by the MCD at their preferred ADA or the ADA caused to be inserted by MIH at the instruction of the Company in case where the successful applicant fails to state either his/her CDS account number or preferred ADA Code, is required to formally open his/her accounts by submitting to the ADA the necessary documents and the account opening fee. No transaction of shares credited to the account can be effected until the account has been formally opened.
