**A NOTES TO THE INTERIM FINANCIAL REPORT FOR THE SECOND QUARTER ENDED 31 JULY 2015.**

**EXPLANATORY NOTES IN COMPLIANCE TO MFRS 134 ON INTERIM FINANCIAL REPORTING**

**A1. Accounting policies and basis of preparation**

This interim financial report is unaudited and has been prepared in compliance with the requirements of MFRS 134, Interim Financial Reporting and paragraph 9.22 of the Listing requirements of Bursa Malaysia Securities Berhad (Bursa Malaysia).

The interim financial report is unaudited and should be read in conjunction with the audited financial statements for the year ended 31 January 2015. The explanatory notes attached to the quarterly financial statements provide an explanation of events and transactions that are significant to gain an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 January 2015.

**A2. Changes in Accounting Policies**

The financial statements of the Group and of the Company have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRSs"), International Financial Reporting Standards ("IFRS") and the provisions of the Companies Act, 1965 in Malaysia.

The total additions to property, plant and equipment for the financial quarter ended 31 July 2015 amounted to RM 1.95 million. During the said period, there was no significant disposal of property, plant and equipment.

**A11. Material events subsequent to the current quarter.**

There were no items, transaction or event of a material and unusual nature which has arisen which would substantially affect the results of the Group and the Company for the period between 31 July 2015 and the date of this report.

The Group revenue for the current financial quarter ended 31 July 2015 decreased by RM 1.84 million as compared to corresponding quarter ended 31 July 2014.

The Group reported a profit before tax of RM 1.04 million and revenue of RM 17.46 million for the current quarter ended 31 July 2015. In the corresponding interim period ended 31 July 2014, the profit before tax and revenue were RM 2.10 million and RM 19.31 million respectively. The Group's reduced performance is due to the lower activity in the current quarter coupled with adjustment of selling price to customers.

**B2. Material change in the quarterly results compared to preceding quarter's results**

The revenue recorded for the Group was higher by 0.01% as compared to the preceding financial quarter ended 30 April 2015. Consolidated profit before tax decreased by 59.31% mainly due to the weakening of the ringgit in the current quarter coupled with adjustment of selling price to customers.

**B3. Prospects for the current financial year**

The Group foresees a continued competitive operating environment for the current financial year. The weakening of the ringgit coupled with high costs of production will inevitably affect the Group's profit margin. The Board of Directors will continue to focus on improving production efficiency, productivity and processes to ensure a satisfactory financial result for the remainder of the current financial year.
