A1. Accounting policies and basis of preparation

(i) Current Quarter Review

The Group revenue for the current financial quarter ended 31 July 2017 was higher by RM 429 thousand as compared to corresponding quarter ended 31 July 2016.

The Group reported a profit before tax of RM 520 thousand and revenue of RM 15.40 million for the current quarter ended 31 July 2017. In the corresponding interim period ended 31 July 2016, the profit before tax and revenue were RM 533 thousand and RM 14.97 million respectively. The Group's lower profit is mainly caused by the higher cost of raw material due to the twin factors of price uptrend and weakening ringgit. The increase in minimum wage price floor effective July 2016 also contributed to the Group's lower profit in the current quarter.

(ii) <u>6-month review</u>

For the 6-month review, the Group revenue and profit before tax for corresponding period ending 31 July 2016 were higher by 5.77% and 67.97% respectively as compared to the current period. The better performance is due to the softening of raw material prices during the corresponding period.
