1. BASIS OF PREPARATION

The adoption of the FRS 139, all financial assets and financial liabilities are recognized at contract dates. All financial assets and financial liabilities are recorded initially at fair value. Forward foreign exchange contract of the group have been measure at fair value and the change in fair value are recognize as gain or loss in the statement of comprehensive income.

3. AUDITORS' REPORT ON PRECEDING ANNUAL FINANCIAL STATEMENTS

The auditors' report on the financial statements for the year ended 31 December 2009 was not qualified.

4. COMMENTS ABOUT SEASONAL OR CYCLICAL FACTORS

The business of the Group depended on the seasonality pattern and cyclical factors of the Lawn & Garden industry in the world market. Approximately 97% of the Group's revenue was generated through export sales while 3% was from domestic sales.

14. PERFORMANCE REVIEW

The Group recorded higher revenue for current quarter at RM3.17 millions for ceramic, as compared with RM2.81 millions in the preceding year corresponding quarter. During the quarter RM4.32 millions was recorded for the general trading & services new business. This has resulted in a profit before taxation of RM117,000, as compared with Loss before taxation of RM1.92 millions in the preceding year corresponding quarter.

15. COMMENTARY ON MATERIAL CHANGE IN PROFIT/(LOSS) BEFORE TAXATION

Profit before taxation for current quarter has decreased to RM117,000, as compared with RM195,000 recorded in the immediate preceding quarter. Profit before tax relative to revenue is lower due to lower profit margin in the general trading & services segment.

16. COMMENTARY ON PROSPECTS

In spite of the difficult world economy environment, the management has managed to explore new product market and business opportunity and will continue the endeavor to work on business growth and expansion. The growth prospect in the new general trading & service segment is promising.
