B1. Review of the Performance

For the quarter ended 31 December 2015, the Group recorded a revenue of RM 145.09 million. This represents an increase of 3.04% as compared to RM 140.81 million in the preceding year corresponding quarter ended 31 December 2014. However, operating profit has decreased by 4.11%, from RM 7.55 million to RM 7.24 million.

Manufacturing Division

The revenue was recorded at RM 30.07 million for current quarter, an increase of 39.67% as compared to RM 21.53 million in the preceding year corresponding quarter ended 31 December 2014. The increase in revenue was mainly attributed to market share expansion which enables the Group to grow continuously. Furthermore, the newly developed products and market penetration had also contributed to higher revenue.

Operating profit has increased by 32.74%, from RM 2.26 million to RM 3.00 million. The increase in operating profit was in line with the increase in revenue.

Distribution Division

The revenue was recorded as RM 114.99 million for current quarter. This represented a decrease of 3.48% as compared to RM 119.13 million in the preceding year corresponding quarter ended 31 December 2014. The decrease in revenue was mainly due to slow down in market demand.

Operating profit has declined by 9.47% from RM 5.28 million to RM 4.78 million, as a result of the increase in costs of distributed products and operating costs due to depreciation of Ringgit Malaysia.

B2. Variation of Results Against Preceding Quarter

For current quarter under review, the Group's revenue increased by 1.60% as compared to RM 142.80 million in the preceding quarter ended 30 September 2015. The profit before tax ("PBT") decreased by 2.33%, from RM 5.16 million to RM 5.04 million.

B3. Prospects

The Board is of the view that the wood panel products' prices are not expected to experience any significant volatility. However, the raw material costs and foreign exchange rates may jeopardize the company's profit performance.

The Company will continue to leverage its competitive strengths of its economies of scale to lower its costs of production, in order to achieve satisfactory performance in coming financial year.
