## NOTES TO THE INTERIM FINANCIAL REPORT

#### A1. Basis of the Preparation

The interim financial report is unaudited and has been prepared in compliance with the requirements of MFRS 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial report should be read in conjunction with the audited financial statements of the Group for the year ended 31 December 2012. This MFRS framework was introduced by the MASB in order to fully coverage Malaysia's existing Financial Reporting Standards ("FRS") framework with the International Financial Reporting Standards ("IFRS") framework issued by the International Accounting Standards Board.

For the current quarter period, the Group's revenue increased by 68.49% to RM12.94 million mainly due to higher demand in the market. The Group achieves a loss before taxation result mainly due to high finance costs charged in the quarter under review.
